

TRUMPETS, 2005

On October 16-17, 2005, the Remnant Bride held for the first time ever a feast in the third-part Millennial period on the new Millennial calendar ([Hurricane Katrina and the Curse of 1920, page 4](#)), the Feast of Trumpets. This was remarkably significant, as you will now see!

Only days before the gathering, Mr. Carroll Sanders asked me what we could expect to take place. I had no idea, nor did we have a specific agenda. All we knew to do at that time was to gather, acknowledging that Yahweh was clearly doing something, evidenced by the incredible things that had taken place and been revealed in the days leading up to this as presented in [Hurricane Katrina and the Curse of 1920](#).

But I did tell Carroll what I hoped would take place, something that I saw as being critical before the Tabernacles Pentecost test of Carmel on December 25-26. In order for Yahweh to pour out the water of His Spirit, even as the water was poured out on the altar set up by Elijah, I saw the necessity that the twelve apostles must first be established; and this is precisely what Yahweh did at this Trumpets gathering! Even as Elijah laid twelve stones to build the altar of Yahweh (1 Kings 18:31), so He Himself, through a man, established the twelve latter rain apostles that complete the twenty-four elders who sit around the throne, and He did so with the most incredible intercessional testimony, as you will see! Let us consider all that took place during this pivotal feast, including some extremely important intercessions.

It is noted in [Hurricane Katrina and the Curse of 1920](#) that men do not recognize the tremendous relevance and significance of the Curse of 1920. In the writing, [He Was Jealous With My Jealousy, page 3](#), we read the following vital truth:

Christians are essentially content and cannot stop the murder of millions of babies each year because of a problem that they themselves began and even unknowingly promote. They know nothing about the Curse of 1920, and are complacently unwilling to do that which is required to stop it. Only a Phinehas can stop it. The curse that is on the church is for a different reason. As was the problem in the days of Phinehas, it is the worship of Baal of Peor, the broad way. Only recently has Yahweh shown the Bride the Curse of 1920, and it is evident that this is the Midianite woman that needs to be destroyed in order to stop the larger curse. **Though the cause of the curse here in Numbers 25 was created by the daughters of Moab, it was ended by slaying a daughter of Midian.** Equally, though the cause of the curse on the church may be the broad way of Baal of Peor, it is evidenced here that the Bride's zeal per the curse of the Midian, the Curse of 1920, can stop the larger and seeming unrelated curse at large. This is evidently why Yahweh showed the Bride this truth regarding the Curse of 1920. Of all the things that are taking place around us at this time, it is this curse that is having the greatest devastation and destruction of all. It is this curse that this Phinehas wants most to see

dealt a death blow. **It appears that if we can stop this curse, we can stop the death that has been caused by the church's continual propensity to go the broad way, the way of Baal of Peor** (emphasis added).

Yahweh has opened the eyes of the Bride to many wonderful and vital truths, and the Curse of 1920 and its reversal is exceptionally important, as you will now further see.

When people began to contact me and make plans and commitments to come for Trumpets, something began developing that was unmistakable. Two black men were coming, as well as two women. Two is the number of witness, and it was evident that Yahweh was setting forth a testimony, a witness, relative to the Curse of 1920. As presented in *The Garden of God – Today*, two major elements of that curse were the black man and the woman. Read [The Garden of God – Today](#) to understand this. What Yahweh might do per this, I did not know; but it was obvious something was developing.

Then on October 11, only four days before Trumpets, Yahweh opened my eyes to see the most incredible and exciting truths! Carroll had called me that morning with some information I had asked him to look into. What he found was that it was in fact the black man who was also responsible for baptizing the first Remnant into death. In Acts 6:9f we read that some from the Synagogue of the Freedmen secretly induced men to bring false testimony against Stephen, and incited the people, the elders, and the scribes against him and have him drug before the Council, whereby he was stoned. Who were the Synagogue of the Freedmen? They were former slaves from Africa (Cyrenians and Alexandrians) and some from Cilicia (where Paul was from) and Asians, who had obtained their freedom.

You will recall that, very significantly, it was Simon of Cyrene, a black man from Africa, whom the Romans “laid hold of,” and he was “pressed into service to bear” Yahshua’s cross (Matthew 27:32, Mark 15:21, Luke 23:26). Why did this happen? Because of prophecy, because the black man is cursed, and as such is a prophetic type of Christianity, which is equally cursed. **Simon of Cyrene was “laid hold of” and “pressed into service to bear” Yahshua’s cross, because cursed Christianity would be “laid hold of” and “pressed into service to bear” Yahshua’s cross.**

But the curse per the black man goes back even further than the testimony here of the curse that was effected when the Synagogue of the Freedmen brought the death of the first Remnant. That curse goes all the way back to when Ham exposed the nakedness of Noah, whereby a curse was placed upon Canaan, and really upon all black men. As noted in *The Garden of God – Today*, clearly the descendants of Ham settled Africa, a cursed continent. Furthermore, we once again saw the evidence of this curse and the black man’s representation of Christianity in the aftermath of Hurricane Katrina hitting New Orleans (read [Hurricane Katrina and the Curse of 1920](#)).

That curse per the black man and the Canaanite is highly relevant to the Curse of 1920 as well. As we have seen, not only was he a part of women’s rebellion and brought forth cursed jazz music, but the origin of the curse goes back to when the father of faith, Abraham, married a cursed Canaanite, Keturah. Nine periods of cursed time later (or 9 x 414 years), the Curse of 1920 began.

After talking to Carroll, I began to see how the black man had been used so extensively as a curse – the initiating act of Ham, the Canaanites, the enslavement of the sons of Israel, the death of the first Remnant, and the Curse of 1920 – and began to consider that when these two black men came, we should have a time when they as representatives would ask forgiveness for their actions on behalf of all black men, going all the way back to Ham, with the hope of reversing the curse that has been on them.

As that consideration came into my thoughts, it had not even fully unfolded when suddenly I began to sense the depth and vastness of this! I had touched something that was incredibly significant! It was so overwhelming that I began to gasp for air and pace about, literally overwhelmed at its awesomeness! Continuing to pace about, I went to the couch to kneel down in an effort to find relief, but there was none. Rising quickly, I continued to pace about, gasping deeply in proportion to the incredible vastness of that which I had just touched, until finally it subsided. Most certainly, there was something of unfathomable significance that would take place if we did this.

I called Kyle Nixon to tell him what I had experienced, and knew that with the two black men and the two women who were coming, we were in a legal position to reverse the Curse of 1920! There would need to be a time when the two black men and the two women would confess on behalf of all blacks and all women their part in the Curse of 1920, even going all the way back to Ham and the garden of Eden, and ask for forgiveness.

As Kyle and I talked, he pointed out that per the seven men who were set apart by the apostles to wait tables (which they themselves should have done), the last man listed was a proselyte from Antioch whose name was Nicholas (Acts 6:5). Kyle's last name is Nixon, which is actually "Nich son," or "son of Nicholas." Nicholas means "people of victory." When he told me this, the windows of heaven opened once again and I further saw precisely what had to take place at Trumpets and why, this time regarding the church.

Yahweh is government, He is law, He is legal, and if we are to reverse the curse that has been on the church, it is very significant to note that there is both a legal origin of that curse, and thereby a specific legal way in which it can be reversed. This is precisely what Yahshua knew and accomplished. He knew that in order to reverse the curse that had occurred in the original garden, He had to intercessorally return to that garden and fix the problem there. Thus, He took [the vow of the Nazirite](#) that legally placed Him in the garden, then went to a garden to pray, and after asking three times that the cup would pass from Him and three times denying it, drank from the cup and thereby took upon Himself all the sins of man from the garden onward. Therefore, when He rose from the grave and ascended to the tent of meeting, by passing through eight days of purification, Yahshua cleansed the garden of God and afforded the restored kingdom to man. And He accomplished all of this legally and intercessorally! And this was exactly what had to happen per the Curse of 1920 and the curse on the church.

So, very importantly - When and from what legal event did the curse come upon the church? There are numerous testimonies to this curse, but one clear testimony is when the apostles established the seven men in their place to do what they should have done (Acts 6:1-6). Again, [seven](#) is the mark of the beast, and with that action they legally corrupted the church, bringing a

curse upon it. Evidencing this, immediately afterwards we see the Synagogue of the Freedmen turning Stephen over to the Council to be stoned and the disbursement of the first Remnant out of Jerusalem. Even as the sons of Israel were taken by force from Jerusalem to Babylon, so by this act of setting up the mark-of-the-beast seven, the church was taken by force from Jerusalem to mystery Babylon, Christianity.

So, now knowing the cause of this curse, and that Yahweh also affords legal solutions to a curse, how could we then intercessorally go back and fix this? Simple! What did Yahweh teach us in *Hurricane Katrina and the Curse of 1920*? In order to reverse the curse of the seven, all you have to do is add the eighth! Explaining this to Kyle, I then asked him – Will you be the eighth man to be added to the original seven? “If you ask me,” was his reply. So, I asked him, and he accepted. **Thus, all we legally had to do to reverse the curse on the church that was caused by establishing the seven, was to add the critical eighth! And that we would indeed do!**

But it is vital to note here that not just anybody could place a man in that position. The original eleven performed that initial act, and the only one who could legally add an eighth would have to be one from their number! Thus we see once again why Yahweh had to preserve the office of the twelfth apostle for today. He first gave that office to a man, Judas; but as clearly stated by Yahshua (John 6:70), that office went to Satan, who, very importantly, kept it viable to this day, whereupon it has now been given back to a man ([The Twenty-four Elders](#)). Thus, that man has all the authority of the original eleven, and can rightfully add the critical eighth, and thereby reverse the curse!

Later, David Shepherd added even greater relevance to this by pointing out that this act was the fulfillment of “the key of David” spoken of in Revelation 3:7 and Isaiah 22:22. In 1 Chronicles 2:15 we read that David was the seventh son of Jesse; but when Samuel went to anoint a new king in place of Saul, 1 Samuel 16:10 tells us that seven sons of Jesse were brought before Samuel, and David was the critical and removed eighth! Once again we find a very important and highly revealing Bible contradiction riddle.

Were the mark-of-the-beast seven sons acceptable to Yahweh? No more than mark-of-the-beast Christianity has been acceptable to Yahweh, and no more than the seven chosen by the original eleven were acceptable. As Yahweh spoke to Samuel, so it is true with the mark-of-the-beast seven work:

“Do not look at his (Christianity’s) appearance or at the height of his stature, because I have rejected him; for God sees not as man sees, for man looks at the outward appearance, but Yahweh looks at the heart” (1 Samuel 16:7).

Yahweh rejected the seven, even as He rejected Saul, and even as He has rejected Christianity. But what then was the vital key here in this obvious riddle concerning David? **The critical necessity of adding the eighth!** Jesse had seven sons, but when it came time to reverse the curse of Saul, Yahweh of necessity added David, the eighth, and anointed him with the oil that was placed in Samuel’s “horn” (1 Samuel 16:1), even the horn of Trumpets that we were about to celebrate.

In Isaiah 22:15-23 (as addressed in [The Soul, page 4](#)), we see that the twelfth apostle who replaces Satan is given the promise by Yahweh:

“I will set the key of the house of David on his shoulder;
When he opens no one will shut,
When he shuts no one will open.”

Of necessity, this is the authority this man has been given as the twelfth apostle. The key of David has been placed on my shoulder. In other words, via the office in which I stand, the governmental rights and authority have been given to me to both see the need for and perform the act of adding the critical eighth in order to reverse the curse on the church. This is this key that opens a door that no one will shut, and shuts a door that no one will open.

I have been given the key of David, and this is why Yahweh showed this man this critical governmental act whereby the curse can be reversed by adding Kyle “son of Nicholas” as the eighth! Again, Kyle’s last name clearly attests to his place as the eighth – “son of Nicholas,” Nicholas being the seventh, a proselyte of Antioch where Christianity began. (Is it any wonder that at Yahweh’s test of Carmel on December 25 there will be two Nicholas being presented? Christianity will offer its Saint Nicholas, or Santa Claus, and the Bride will present forth its “son of Nicholas,” Kyle Nixon, the eighth. Which one will be accepted by Yahweh?)

Thus our Trumpets work was being set before us. We would reverse the Curse of 1920 by the two black men and the two women confessing their parts in that curse and asking forgiveness, and we would reverse the curse on the church by adding the critical eighth to the seven originally set forth by the first apostles. But there was still more to learn before that pivotal day.

The day before others were to arrive, or October 14, Brendan, Cary, his daughter, Kim, Carroll, and Russ had come early and we went for a walk around a local lake. I would need to talk to each individual involved in this intercession; and not really knowing some of them, I did not know what their responses would be. If any one of them rejected taking part in this, it would terminate the entire intercession.

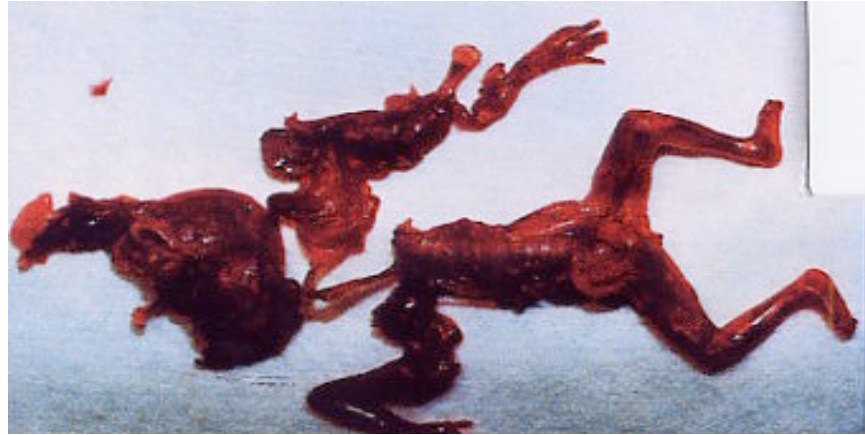
I asked permission to talk with Kim, and as we walked around the lake, Kim and I lingered behind the other men. As we went along, I explained the intercession that was unfolding and asked her if she would be willing to represent all women and to repent on their behalf. Kim agreed, and even sensed beforehand that something like this was unfolding. Just before the trip she had actually been rereading *The Garden of God – Today*. So, Kim’s agreement made half of one part in this intercession possible.

At a resting place, Kim and Cary returned back to the car while Brendan, Russ, Carroll, and I continued our walk around the lake. As we entered the final course, Brendan spoke up that there was a third part to this curse. When he said this, my mind began searching for that third part, three certainly being a complete number. He began telling me of what he was seeing, but I could not hear him. Instead my mind was awchirl with what I was considering. I asked him to repeat what he said, but still I only heard sounds. Having to interrupt him a second time, I began to explain the critical third part of this Curse and how it too had to be reversed.

When the controversy regarding Terri Schiavo and her murderous death was taking place, I began a writing titled *Terri Schiavo and the Curse of 1920 – Where modern-day euthanasia came from, and where it is taking us!* I never completed that writing, waiting instead for Yahweh to provide more truth and relevance pertaining to it. What we find is that euthanasia as we know it today, and to a great extent abortion as well, began in 1920 with the publication of a book by two German doctors – Dr. Karl Binding, a lawyer, who was a Professor of Law and Doctor of Philosophy, and Dr. Alfred Hoche, who was a Doctor of Medicine and Psychiatrist. The book had the ominous title – *The Permission to Destroy Life Unworthy of Life.*

This philosophy of death controversially made its way into the medical community in Germany, and when Hitler came to power in 1933, the foundation had already been laid among doctors and nurses that, as proponents of this 1920 curse, afforded the murder of 6 million Jews and 12 million other “undesirables.” Today, nearly 50 million children are murdered each year by the medical community that is continuing to operate under the Curse of 1920 that Hitler perfected, and euthanasia is ever increasing, evidenced by what happened to Terri Schiavo. To demonstrate just one small faction of the cruelty of this curse, a picture is worth a thousand words.





Already we had the testimony of the reverse of the Curse of 1920 per Yahweh providing two black men and two women. But what about this third part that clearly was a substantial part of the Curse – the grievous guilt of the medical community. Who could legally stand in the place with these other four to confess the sins of doctors as well and ask Yahweh to reverse the Curse of 1920? They had to be a doctor. The answer was in the man who noted there had to be a third part – Dr. Brendan McElroy! Brendan is a medical doctor in an emergency room on Long Island. Thus, Yahweh had wondrously provided intercessors for all three parts of the guilt of the Curse of 1920 – the black man, the woman, and the doctor!

But there was another pair of men gathering here for Trumpets that would, of necessity, play a part in this repentance as well – two pastors. In Jeremiah 23:1-4, 25:34-36, and Ezekiel 34:1-10 we read of Yahweh's great indignation against pastors/shepherds. For 2,000 years pastors have fleeced the sheep and fed them dung, the word of God processed by the flesh. They have been Judas Iscariots, or Judas "men of hire." Intentionally or unintentionally they have destroyed and scattered the sheep and driven them away from truth and have not healed them. These two

pastors whom Yahweh sent here for this time of repentance would equally confess all the sins of pastors and ask for forgiveness.

Thus the scene was set for the Trumpets repentance – two black men, two women, two pastors, and a doctor, for a total of seven! Herein Yahweh once again attested to the curse that has been on man, the mark of the beast, the illegal shortfall number seven that demands an eighth. (And actually, the reality of this was not even recognized until the Trumpets intercession was over.)

The morning of Trumpets, October 16, I went on a walk with the other woman, Linda, and her brother, Eric, who had invited Linda to come, the man whom Yahweh is using to reveal His Millennial calendar. I did not know Linda at all, and was anxious when I told her about the Curse of 1920 that began when women obtained the right to vote. Eric had explained some of this to her, and I was quite relieved when she told me that she had actually never voted in her life, nor registered to vote. It was something she did not believe in. In this regard, she was actually a political virgin, even as Brendan had never participated in any abortions. They were both spotless lambs in these regards. Linda gratefully accepted the opportunity to stand in the place of all women as well and ask forgiveness for the sins of women abandoning their place.

This made possible the testimony for women, as well as the two pastors, who both readily agreed the day before as we began to see what Yahweh was doing. Of course Dr. McElroy readily agreed. All that remained were the two black brothers, Stanley and Tommy. My walk with them was next.

We took a long walk, for there was much to discuss regarding this. Tommy had told me before that no one knew better the curse that was on the black man than the black man himself, and both of these brothers were very willing to stand in the place of all black men from Ham to today and ask forgiveness, and to ask that Yahweh would reverse the curse on the black man. **Thus, the complete intercessorial testimony was established!**

It is important we add something here that is very likely a fulfillment of Scriptures at one level. On the morning of the 14th, Carroll pointed out a truth that was to be an integral legal part of our confession and intercession. The book of John speaks to the kingdom of heaven in the Millennial reign, and we find unique to it the account when Yahshua breathed on the disciples after He rose from the dead. This is the very thing we had hoped for, as expressed in an [e-mail](#) sent out just prior to this gathering – that Yahshua would breathe on us. And He did! But what was most striking, especially per what we were about to do, was what He said next. In John 20:23 we read Yahshua's unique subsequent statement:

“If you remit the sins of any, their sins have been remitted them; if you retain the sins of any, they have been retained.”

Very importantly per this Trumpets intercession, we therefore knew that when we gathered to pray and ask for forgiveness, we would remit the sins of each one of these groups, and they would be remitted.

After lunch, we gathered to reverse the curses, not only the Curse of 1920, but the curse from the beginning of the church when the apostles established the seven. And it was with great hope that we noted that one year prior equally on Trumpets per the Millennial calendar, the Red Sox beat the Cardinals in the most miraculous World Series win in baseball history, setting a World Series record of eight straight wins in one playoff year and reversing the curse they too had been under since 1920 when they sold Babe Ruth. Now, exactly one year later, we were getting ready to accomplish intercessions that would reverse the Curse of 1920 and the curse on the church.

We began with what turned out to be a time of weeping and contrite humbling for the grievous sorrows that have been placed on man by these curses. This was followed by Stanley and Tommy kneeling in the center of the room facing each other like unto the two covering cherubim on the mercy seat (though they did not know the reason for this at the time) and praying, asking for Yahweh's forgiveness for the black man and confessing their sins and asking Him to reverse the curse that has been on them from Ham. And thereupon we remitted those sins and they embraced.

Next Kim and Linda knelt in the middle of the room, likewise facing each other as two covering cherubim. They too confessed the sins of all women for their part in the Curse of 1920 and asked forgiveness for all women in their shortfalls and sins as women, going all the way back to Eve. And thereupon we remitted those sins and they too embraced.

Next the two pastors knelt in the middle of the room, likewise facing each other as two covering cherubim and they immediately embraced and humbly confessed and repented of all the sins of pastors. And thereupon we remitted those sins, asking Yahweh to forgive them for they knew not what they were doing.

Then Dr. McElroy knelt in the center of the room. I had decided beforehand that he would kneel alone, since there were none intercessorally qualified to legally represent that guilt, but by unction and unplanned I asked Kyle to kneel with him. Only days before, Kyle had told me that he was responsible for the abortion of three children that he had conceived, for which he had grievously repented. Thus we had the doctor, who represented those who perform the abortions and euthanasia, and one who had presented himself to them and requested their ill actions, and they too faced each other as two covering cherubim and humbly embraced in prayer. These two men likewise asked for forgiveness, including prayers by Kyle for those who have performed acts of homosexuality and other like sins, as well as the part of rock and roll in the curse, as he was once involved in punk rock. And thereupon we remitted those sins.

What was most striking about this, as we realized later, was that by asking Kyle to kneel with Brendan, who was the seventh, **we actually added the all-important eighth, thereby reversing the curse, effecting that much needed legal testimony!**

When these two men finished praying, I asked Kyle to remain there. In 2000 Kyle had asked per an intercession for my daughter, Rebekah, ([A Lesson From Intercession, page 8](#), last half) that I anoint him with oil. I denied him this at that time, but knew it was now time to fulfill that request. Based on the authority given to me as the twelfth apostle, as well as the right to use the key of David who was the eighth and was anointed with oil from the horn of Samuel, with tears I

generously anointed Kyle with olive oil as the eighth man who was established to serve tables, legally reversing the curse on the church, and laid my hands upon him, offering Him to Yahweh. **The curse that was caused when the eleven established the seven, was reversed when the twelfth established the eighth.**

And very significantly, Kyle was an apostle, something that was lacking with the first seven. What the apostles should have carried out but did not, I installed an apostle to serve in that function. And what this did as well was to afford two men the legal place with the first Remnant – myself as the twelfth apostle, and Kyle as the eighth man to serve tables. Thus we now have a legal two-part link to the first Remnant.

What have we provided for the first Remnant? As it is written in highly Remnant Hebrews, 11:40 – “because God had provided something better for us, so that apart from us they should not be made perfect.” The first Remnant entirely needed the second Remnant to make perfect that which they began, for without us they are incomplete. This is the fulfilling work Yahweh has performed following the 2,000 year breach in time that has been occupied by Satan-dominated Christianity. Yahweh has done all of this by His hand, fulfilling His word, and completing His promise by adding the critical second part. Praise be the name of Yahweh!

Thus we see as foreshadowed in John 20:22 and Acts 10:44-45, Yahshua breathed on us, reversing the curse, calling clean that which has been unclean, and as we will now see, establishing the latter rain twelve apostles. He breathed on us, and these wondrous things were done!

Let us now consider what He performed in beginning the restoration of all things, effecting the Elijah work, doing once again that which He did in the beginning of the church, establishing the latter twelve apostles. And, we will see the amazing and wonderful legal testimony He has effected in performing this vital work.

THE LAST DAYS TWELVE APOSTLES

In the opening of this writing, it was noted that even as Elijah laid twelve stones to build the altar of Yahweh (1 Kings 18:31-32), so Yahweh Himself, through a man, established during Trumpets the twelve latter rain apostles that complete the twenty-four elders who sit around the throne. And as you have seen already, He did so with the most incredible intercessorial testimony! Let us now consider this truly wonderful and amazing work.

On the evening of October 15, the evening before Trumpets, Carroll and Russ went to the airport to pick up the remaining four men for the gathering. I received a call from Russ; his daughter, Ruhamah, was in a serious rollover accident and he did not know her condition. It is quite noteworthy that in the recent writing titled [Hurricane Katrina and the Curse of 1920, page 5](#), we addressed the significance of Ruhamah’s testimony. Because of its significance, we will review it here, but first let us relate what happened in that accident.

Ruhamah was driving a Ford Bronco on a country road and reached to get her cell phone, whereupon she went off the road. The vehicle rolled over eight times (as reported by a witness), striking a telephone pole during this course. She was thrown into the back seat and the engine was jammed into the front seat, while the top was crushed down upon her. An ambulance was called, and it took forty-five minutes to get there, all the while Ruhamah remained in the crushed vehicle. When they arrived, immediately upon getting her out of the vehicle and into the ambulance, the telephone pole fell and crushed even further the Bronco. Ruhamah escaped a two-blow death sentence with no cuts or bruises, and was released to go home. In accordance with her name, Yahweh had mercy! You will also note that the vehicle rolled eight times, the number of reversing the curse, the very thing that would take place over the next two days.

Through the winter of '81-'82, Russ took off about six months and did nothing but study the Scriptures 8-10 hours a day. One night he and his wife had marital relations, and afterwards he was standing at the window, looking outside, when Yahweh spoke to him. He told Russ – your wife has conceived, the child is a girl, and you are to name her Ruhamah. Nine months later on October 2, that little girl was born.

At the time of that recent writing, it was obvious her name and the circumstances pertaining to her conception were meaningful for us today. And this was even more true now! “Ruhamah” means – “mercy”; and that is precisely what Yahweh dramatically testified in that violent car accident on the evening of our Trumpets gathering.

The name that Yahweh told Russ to call this child is from the book of Hosea. Hosea had three children by a harlot, Gomer, and Yahweh equally spoke to him their names – first a son, Jezreel; then the daughter, Lo-ruhamah; and finally another son, Lo-ammi. The “Lo” in these two names means “not”; therefore Yahweh was saying that He would not have mercy, and they would not be His people (Lo-ammi).

But in verse 11 of chapter one, we see a union of Judah and Israel under “one leader, and they will go up/ascend from the land, for great will be the day of Jezreel.” At that point, in the very next verse the two united ones are called Ammi and Ruhamah, or “My people” and “mercy,” which attests to what Yahweh is performing now for His Bride, and precisely what He both performed and testified to at this Trumpets gathering.

The name, Jezreel, was a name also further cited in that writing. It is the city specifically identified with Carmel and Gideon. Thus, evidenced by both the testimony of Carmel and Jezreel, as well as the offerings that ascend per both Carmel and Gideon, and the striking similarity in the divine directed naming of both Lo-ruhamah and Russ' Ruhamah, and now the severe accident Ruhamah was in on the evening of our Trumpets gathering wherein she escaped harm from the two-blow strike, clearly Yahweh was speaking to us that He is having mercy on the Bride who will ascend.

When we finally got to bed that night, Russ was sleeping immediately to my left. As I lay there, for the first time I counted the number of people who had come. Including myself, there were thirteen. That would mean there was the pattern of a one-and-twelve government! But there was a seeming glitch in this – two of them were women! But my mind went back to a conversation

only days before when Tommy had asked me on the phone what my feelings were about the black man. I told him that though the black man was cursed, when one enters into the higher dimension of the kingdom of heaven, he and I are one. Besides, we are all cursed. When I said this, I was challenged about the woman being one as well at that higher dimension.

On this evening of Trumpets, Yahweh was giving the clear testimony of having mercy. Could it be that He would attest to that mercy and add two women to the twelve apostles? I asked Russ – “Do you know how many people are here?” He answered – “Thirteen.” “That’s a one-and-twelve government,” I noted. He concurred. “This accident with Ruhamah is very significant, Russ, very significant!” He concurred, and we went to sleep.

That next morning after breakfast is when I went on the walk with Linda and Eric. I am not the kind of person who holds things in. I am very open, and it was impossible to talk with these two without being entirely open about what I was seeing – the establishment of the twelve, including two women! The more I talked about it, the more evident it was that this was what Yahweh was doing. You know of the intercession that took place later that day; let us now examine these twelve people and see why it was that Yahweh chose them. This is exceptionally revealing per the ways and works and government and intercessions of Yahweh. All in all, in these twelve people, Yahweh attested that He is having mercy, and will reverse the curse.

Let us begin by recounting what was also stated in the opening of this writing. From [He Was Jealous With My Jealousy, page 3](#), we read, giving special attention to the last sentence:

Christians are essentially content and cannot stop the murder of millions of babies each year because of a problem that they themselves began and even unknowingly promote. They know nothing about the Curse of 1920, and are complacently unwilling to do that which is required to stop it. Only a Phinehas can stop it. The curse that is on the church is for a different reason. As was the problem in the days of Phinehas, it is the worship of Baal of Peor, the broad way. Only recently has Yahweh shown the Bride the Curse of 1920, and it is evident that this is the Midianite woman that needs to be destroyed in order to stop the larger curse. **Though the cause of the curse here in Numbers 25 was created by the daughters of Moab, it was ended by slaying a daughter of Midian.** Equally, though the cause of the curse on the church may be the broad way of Baal of Peor, it is evidenced here that the Bride’s zeal per the curse of the Midian, the Curse of 1920, can stop the larger and seeming unrelated curse at large. This is evidently why Yahweh showed the Bride this truth regarding the Curse of 1920. Of all the things that are taking place around us at this time, it is this curse that is having the greatest devastation and destruction of all. It is this curse that this Phinehas wants most to see dealt a deathblow. **It appears that if we can stop this curse, we can stop the death that has been caused by the church’s continual propensity to go the broad way, the way of Baal of Peor** (emphasis added).

The most incredible and noteworthy thing about the latter rain twelve apostles is the contemporary nature of their legal testimony – corporately they were wholly fitted for the time in which we now live. In the throws of the Curse of 1920, these twelve individuals legally and intercessorally attest to the reverse of that curse, as well as to the reverse of the curse that has

been on the church since the first eleven established the seven. **These twelve apostles are like a small seed, a legal testimony, of the reverse of these curses. Yahweh is having mercy, and included in these twelve is His divine testimony of that mercy.**

As we saw, the Curse of 1920 was effected in three primary ways – the blacks, women, and doctors. As a legal testimony of Yahweh extending mercy to these and His commitment to reverse the Curse for which we interceded, He placed among the twelve – two black men, two women, a doctor, as well as a man who was responsible for three abortions. This is very important per what was attested regarding Phinehas and the need for a man who is jealous with Yahweh's jealousy to reverse the Curse of 1920, so that the greater curse can be stopped as well. And as a testimony of Yahweh having mercy towards pastors in their failure as shepherds to lead the sheep, having defiled them instead, Yahweh placed two pastors among the twelve.

Thus we see an important part of this contemporary seed testimony. These are not insignificant testimonies, but are legal commitments and evidences on the part of Yahweh. And these are not super-people either, but very common and unassuming people. Once again, Yahweh has chosen the foolish to shame the wise, the weak to shame the strong, those who are not that He may nullify those who are. And very importantly, this company of people in our very first act interceded for each of these parts, remitting the sins of each, even as Yahweh has attested by placing them among the twelve.

Additionally, not only is there the testimony of the reverse of the Curse of 1920, but the reverse of the curse that has been on the church from its beginning. Very importantly, Kyle “son of Nicholas” stands in the place as the redeeming eighth. First was his place as the eighth of the seven who confessed their sins and sought repentance; and he was likewise the eighth man added to the seven whom the original eleven set forth, initiating the curse on the church. Thus, Kyle affords as an apostle a critical legal two-part testimony of the key of David – adding the redeeming eighth!

These eight people afford an essential legal and intercessional contemporary testimony in the second Remnant twelve apostles. And what about the other four? Linda's brother, Eric, affords the testimony of this being an entirely new time into which we have now entered. Eric is the one whom Yahweh has used to reveal the new Millennial calendar, upon which these feasts have been based.

Kim's father, Cary, has guided and instructed her in the Bride truths, and he was here as well. Actually, Cary was the first person to believe the Remnant Bride truths back in 2000, and he has never departed from them. Another man, Brian, found these truths only in April, and has thrilled with them ever since. Cary is over five years in the Bride, and Brian is just over five months; yet when Yahweh established the twelve apostles, they received the same reward. These two men attest to that which Yahshua spoke in Mathew 20:1-16 regarding all who labor in the vineyard receiving the same wages, despite how long they labored.

And the twelfth is the “lad,” David Shepherd. He is the youngest in his walk with Yahshua, though he is now fifty years of age. David is the lad who brings bread given to him by his mother, Jerusalem above, and gives it to a man to bless and to break and to multiply among the

many. Fitting to his name, David Shepherd is the one who revealed the testimony of the key of David, the governmental act of adding the eighth as evidenced when Samuel anointed David, the shepherd, as the eighth.

Now that you see the profound way that Yahweh has set forth this contemporary seed testimony of His redemption of man, we are going to add something that is surprising, yet actually encouraging and confirming.

Yahweh is government, and He performs His works according to His legal patterns. Why? Because they are legal links. Why do you have the hair color that you have? Why are your eyes the color they are, and why is your skin the color it is? It is because of government, patterns. All that you received physically is laid out and passed along from generation to generation in an uninterrupted governmental pattern that is bound in your DNA. That DNA is replicable throughout your entire body; and when you have children, that DNA is passed along to determine how they will look. From the moment they are conceived, they too are governmentally set in their appearance.

Everything there is in life follows a like “DNA” structure. Nothing is haphazard or random but follows a divinely set order; and if we had eyes to see, even as we are only now understanding DNA, we would see this governmental order. And it is this order that the Bride is seeing and using to effect the defeat of Satan and the reverse of these curses. And it is this order that impacted how one of those seats was still yet to be filled.

Before I left Washington state, Kyle asked me who would be the “Judas” among the twelve? Based on the way Yahweh had used Kyle in the past, I assumed that he might fill that place. But I did not recognize that Kyle’s critical role as such was finished and he would now be used as the redeeming eighth. It is quite interesting that Kyle’s willingness to be used for ignoble purposes, qualified him to be used for noble purposes.

After I moved here, Yahweh revealed to Kyle that he was one of the twelve apostles. Kyle needed that very much at the time, for it gave him resolution in his actions. But quite interestingly, there was one other man among the twelve whom Yahweh had also told many years before that he was one of the twenty-four elders. That was Russ, one of the two former pastors.

On the day of Trumpets, only minutes before the intercession, Russ came to me and asked when we would be doing the intercession. He was going to leave right afterward, even though the gathering was set for two days. He wanted to get back to his business and his family. It shook me when he asked this, for this was clearly an incredible thing Yahweh was doing, and to leave early was to cut it short. As we gathered in the living room, I went to the bath and bowed before Yahweh. When Russ told me this, my response was that Yahweh was using this to humble me, and humble me it most certainly did. In fact, it was like a burial inside me, which is what the office of Judas is to effect. This was why we immediately got to the intercession and why my own heart was made tender to weep. In weakness came strength, and the intercession took place with no extraneous delay or distraction, but was to the point and with focused effectual purpose.

But this did not resolve the problem created with Russ leaving. Immediately after the intercession he got his bag and surprised the others with his departure. This especially bothered Carroll, his pastor friend, and took him to his face in contrite prayer.

That evening on the front porch, Carroll and I talked about this. I noted that his act was a “Judas,” leaving early; and at that point Carroll brought up another pastor, Robert (Bob) Pollard, who had wanted to be here, but could not come because of a very important wedding that was already scheduled for October 16, and was in fact intercessorial for the Bride.

The testimony was growing more and more obvious. What were the chances that there would be three Assembly of God pastors who were an active part in the Bride at this critical time? There had to be two witnesses to represent pastors, and of all those who were gathered, it was inevitable that one of those two pastors would represent the betrayal of Judas. Why a pastor? Because pastors are Judas Iscariots, Judas “men of hire” (the meaning of Iscariot). One of those two pastors present at the gathering would fail, and Yahweh chose Russ to be that one. Even when Russ was deciding what he was going to do, he told me later that he recognized that what he was doing by leaving early, before the time, was in the testimony of Judas; but even so he knew that was what he had to do.

The next morning, Brian wrote down all of the ages of those who were there, and examined them in their order from oldest to youngest. I asked him who was number seven, wondering if it was Russ. Not knowing why I asked, Brian answered – Russ! I was beginning to see then that the governmental “Judas” about whom Kyle had enquired was Russ.

Interestingly, “Russell,” like Adam or Edom, means “red.” Of course in like testimony, Esau’s name was changed to Edom when he sold his birthright. What happened to Russ was the prophetic fate of all Adam men. Attested by Judas, we pursue after the natural, and betray Yahshua for money. But Yahshua clearly said – “No one can serve two masters; for either he will hate the one and love the other, or he will hold to the one and despise the other. You cannot serve God and mammon” (first Remnant Matthew 6:24 and second Remnant Luke 16:13; not in Mark). What Russ did cost him his promised place as one of the twenty-four elders.

But the price he paid and the decision he made will be just as decisive for everyone when we are faced with selling all and placing the money in the money box. Russ was a type, a vital present-day testimony for all men – you will either hold onto your money and possessions and stay in your Adam flesh and lose the right to rule and reign with Yahshua, or you will give up everything and enter into His Millennial reign as one of the blessed and holy (Revelation 20:6). Russ was poured out as a living sacrifice, as a testimony, that he and you and everyone will soon have a choice – to give up everything, both possessions and even family, if necessary, and follow Him, or hold onto the things of this world and remain in Adam/Edom flesh!

What is the purpose of a Judas? His purpose is to baptize into death and preserve an office for another. This Russ did. He first baptized me into death, and he preserved that office for another. But this time, we did not have to cast lots, for we knew who it was who should fill it. Yahweh had already provided a replacement – a man whom He had already been using in a very vital way, especially regarding the governmental testimony of adding the eighth – Bob Pollard. I

called Bob on the 18th and told him what had taken place and asked him if he would take Russ' place. Like the other eleven he was dumbfounded and amazed. But also like the other eleven who only the day before had given their affirmation with a resolute "I will" as an answer to the proposal to the Bride (Russ was not there to give this affirmation), Bob then added his humble "I will." Thus, in yet another incredible and actually encouraging testimony in that Yahweh repeated the pattern of the original twelve, He evidenced that it was He who was doing these things, and we were simply walking them out, one amazing and wondrous testimony after another. And very importantly, Yahweh preserved His two-pastor testimony.

Very interestingly, when Linda went home, her sister and mother began asking questions about the gathering. Linda was being evasive in answering some questions, but they insisted in knowing if the twelve apostles were there. She said, "Yes." The next morning, Linda's mom asked a most interesting question. Here are Linda's comments, starting with her mom's question.

"SO was there a Judas there!" I said funny you should ask...yes there was. Things needed to happen the same as before, only now we have the chance to make right what was wronged.

So very well said – "we have the chance to make right what was wronged." What a marvelous opportunity! Even as it is written and we noted before – "because God had provided something better for us, so that apart from us they should not be made perfect" (Hebrews 11:40). Yahweh is making all things perfect.

This completed three days of intercession and governmental activities. All that remained was to go to Russ and tell him about this. The next day Carroll and I dropped the last three men off at the airport and drove across Missouri to talk with him. I approached the matter entirely governmentally, and not personally, and Russ acknowledged this. He accepted what had to take place without any rejection or reprisal, and affirmed that all he wanted to do was the will of the Father. Like the others, he was not seeking any title or office, and was not offended. I told him then that I was very grateful for Yahweh making a man like him for this moment. Like Kyle, he was willing to be placed in a testimony of ignoble use. May his reward be great in the kingdom of heaven.

But for all of us, whether we are used nobly or ignobly, may we always have the attitude of the servant who did the will of the master – "We are unworthy slaves; we have done only that which we ought to have done" (Luke 17:10). The fact is, we are all Judases by nature, we are all cursed black men by nature, we are all Eves by nature, and it is only by His grace that we do otherwise. Gratefully, what is impossible with man is possible with God, and we all must realize from where that grace to do His will comes, lest He once again take us to the place where it is made all too evident. "What do you have that you did not receive? And if you did receive it, why do you boast as if you had not received it?" (1 Corinthians 4:7) Ever remember what you truly are, and put your foot on the neck of pride. Yahweh used Russ to show us what we all are, and by His grace we will not follow in that way when our test comes.

The day in which we now live will afford a testimony that is incomparable on a personal level. We will either be Judas and betray Yahshua for mammon, or we will give up everything and

enter into immortality. We will either be an Edom and sell our birthright for the porridge of this world, or we will give up everything and follow Him.

Thus we completed four days of intercession. And most encouraging, as Carroll and I drove back to Salem, we did so in a very great rain, giving us hope for the latter rain.

OTHER IMPORTANT TESTIMONIES

It happens though that Russ was not the only one to give up his seat to another. It has been said before that Yahweh will use a woman when a man fails to respond. That was certainly the case per the two women who are now apostles. In both cases, the seat they occupy was to go to a man, but that man failed to come.

The gathering was planned to be in the home of Jim Neumann. But one week before the gathering when others were to arrive, I received an e-mail from him stating – “If you are to be used as an Elijah/12th apostle it has been hidden from me for the current time. Your leading and vision is not in line with the direction the Father is leading me. I accept the possibility that I may be the one who is deceived, but I must walk within the faith that I have been given.” Jim backed out of holding the gathering in his home, and did not attend. Of course at first this was very unsettling, but the more I considered what Yahweh was doing, the more excited I became. I realized that Yahweh’s design was to hold this in the home that He had so wonderfully blessed me with when I moved here. Let us digress on this.

As noted in [The Twenty-four Elders, page 8](#), and in the video, [The Twenty-four Elders](#), Yahweh’s governmental design has been to take the one who stands in the office of the twelfth apostle, and from him build a Bride. This is evidenced inasmuch that Yahweh put Adam to sleep, opened his side, took out a rib, and from it formed a bride. We have noted that that rib represents one of the twenty-four elders, the twelfth apostle; and in truth he has the responsibility to form the other twelve ribs, the other twelve elders, that are the legal testimony of the Bride. Therefore, it became obvious why Yahweh had these twelve “ribs” to come specifically into my home in Salem – for the other twelve to be governmentally established in the home of the rib that was to form the Bride. It was all government, and Yahweh wanted only these twelve governmental parts present under the covering or home of the twelfth apostle. There were none others present.

After reading [The Golden Image](#), Jim rejected this man as the twelfth apostle and thereby lost his seat as one of the twenty-four elders. As it is written in Acts 3:23 – “And it shall be that every soul that does not heed that prophet shall be utterly destroyed from among the people.” Does this mean Jim will not return? Not necessarily; we will have to see. Even as he said, his action was based on his faith at the time. The fact is, Jim was not to come so that his place could be taken from him and given to a woman. It is most reassuring and confirming that two men had in fact planned to be here but backed out. There would have been twelve men, but Yahweh ordered that this critical testimony regarding the woman be governmentally established, thus two men

gave up their places. And at some point, based on what we read here, any who reject this prophet will not reign with Yahshua, even as we saw in the writing – [The Golden Image](#).

The other man who did not come was Bruce Ramsey. Bruce did not come because the woman he has been seeing went through a situation that turned him upside down. When Bruce found out what he missed, he had known that something dramatic would take place and was very upset at his failure. But I encouraged him not to be. Bruce's previous two wives were not faithful to him and hurt him very much, and the event that took place tested his trust in women all the more. I told him that his sacrifice was for the purpose of delivering women from the very curse by which he has been hurt so deeply. The very deliverance they needed, from which he had suffered so much, has been legally provided by him giving up his office. Bruce Ramsey became the ram caught in the thicket so that the lives of women could be delivered.

It is further interesting that another man did not come who, much earlier, had talked about coming. His name was Mark. I do not control prophecy, but when Mark did not come I was relieved, for there were quite a number of things that concerned me about him. In type he was Mark Christianity, which will not rule and reign with Yahshua. Does this mean that this specific Mark, or any Mark, will not be in the Remnant? Not at all; but during this highly prophetic and intercessional period, there had to be a Mark Christianity testimony that failed as well.

And speaking of "Mark," let us note some of the incredible similarities in these two women who are apostles. First, they are both the identical age – 39. Kim is married to a Mark, a name that has been most fitting for him up to now, and Linda had just broken up with a man named Mark. Both women came with a male authority – Kim with her father, Cary, and Linda with her brother, Eric. Even as there were brothers among the first apostles, we have a brother and sister, and father and daughter. Also, quite amazingly, both women had quit shaving before coming. What is the significance of this? Hair is prophetic of glory, and both women intercessorally testified that glory would return to them. This is the same testimony per Samson, whose hair had equally been removed, but upon its restoration regained the much needed strength to defeat the Philistines, both testifying of the glory that returns to the Bride.

There were so many similarities between these two women that at one point Kim told me she was afraid to ask Linda what her middle name was. The next morning she told me the answer; yes, they both have the same middle name – Marie. Also, both women had just recently moved, and neither have had children. They were both devoted Catholics, then became Protestant Christians, and are now Remnant Bride, and now the two women apostles.

While we are speaking of people and their testimonies, there were two women who sent some very interesting information. First, there is a lady named Anna who spoke truth once before to the Bride. In 2003 she said that the Bride would die that year and be born again in 2004, which indeed happened. On October 8 Anna sent an e-mail with the following:

I had a dream last night. You were outside and Yahweh told you to count the stars. You looked up and there were only twelve. You were disappointed that there were not more, and Yahweh told you – "My stars are for signs, seasons, days, months, and years. Every star

prophesies of Me. There are only twelve stars, but the stars became scattered and many, but all came from the twelve stars.” Perhaps this means something to you!

Eight days later the twelve stars/apostles were set forth in the heavens, and many Bride members/stars will come from this governmental work, as well as all the host of heaven, and all will specifically prophesy of Him and His works, even as we have seen so wonderfully in these twelve apostles.

Another testimony was sent by Carol in New Zealand. Quite interesting, Carol was born at almost midnight, December 25. But when the birth certificate was filled out, they dated it December 26. Thus she has the same two days testified per her birth, that we will experience at the Tabernacles Pentecost on December 25 and 26. Here is her e-mail:

Also, during the weekend of 16/17 October while you were all together, Yahweh spoke to me that the legal transfer had indeed occurred from Peter to the Remnant Bride during this feast of Trumpets!! Praise Him!! This is such an awesome time!

There is yet another man who was not here whom I always assumed would be one of the apostles, and would have been so if he had come (many are called, but few are chosen) – my dear friend and savior (with a lower case “s,” but nonetheless so, who delivered me from destruction in 2003), Peter Douglas. But Peter had to be a Peter (which he always told me he was such) and denied me three times, the last time denying that I was the twelfth apostle, equally costing him his place as one of the twelve. It seems that Peter not being here fulfilled in type the very thing Yahweh told Carol – the legal transfer of the kingdom rights from Peter to the second Remnant.

THE LEGAL RIGHTS TO ASCEND ALIVE

Everything you keep seeing per the Bride is the administration of law. The feasts, the calendar, the curses, and the reverse of the curses, are all a matter of law. Even when it finally comes down to it, the hurricanes, the baseball games, the elections, are all law. The kingdom of heaven we know today is law. Satan’s rights to desolate the church for the last 2,000 years is strictly law. The formation of the second Remnant today is possible because of law. The Remnant’s rights to begin receiving the things we are receiving now are all a matter of law. As of Passover, 2004, man entered into the Millennial reign and therefore we can legally begin receiving things that before were illegal. Thus, many of the things the Remnant carried out in the past without the expected results were critical intercessions, seeds, waiting until it was legal to receive that for which we had actively believed Yahweh to perform.

It is very significant and telling that the first Remnant did not and could not see these legal matters regarding the kingdom, nor did or could Christianity. They were both premature, before the time, even as Saul and Judas’ premature departure from Passover represented. That legal right has been reserved for the second Remnant. Why? Because only now is it time that these things can even take place, can be fulfilled; and understanding and acting on these legal matters

now is entirely essential. Case in point – we simply acted by gathering at Trumpets, and Yahweh provided the needed results. We act, He provides the results.

In the writing, [Joab](#), which came about from Kyle baptizing me into death in 2002 when he rejected me, we saw the critical purpose of law versus misplaced feminine mercy. “Joab” means “Yahweh father,” and his testimony reveals Yahweh as law. That is what this man is as well. As pointed out in that writing, I am a Joab, law, and I cannot change this. Yahweh has so made me as law, and I see everything in that light.

Law is the only way in which the kingdom can be changed and provisions from above can be effected and obtained. **If Yahshua restored the original garden through the legal act of the vow of the Nazirite, how much more important and relevant is it that the Elijah second Remnant, who lead the way into that Millennial kingdom, equally restore all things by legal means? There is no other way possible.**

Evidence of this necessity of law to effect for us that which is from above is the revealing testimony of how Jerusalem (the type of Jerusalem above) was obtained by David who had just been made king over all Israel and Judah.

The Jebusites possessed the city, and it was called Jebus. The name “Jebus” means “trodden down,” and it was in fact a type of Christianity, the kingdom of heaven that has been trodden down by Satan and kingdom man for 2,000 years. So how was Jebus to be captured and become the city of David, Jerusalem? By law! Very importantly, Joab, who is law, led the way up the water tunnel and was the first to strike a Jebusite, making him chief and commander and securing the city (2 Samuel 5:6-10, 1 Chronicles 11:4-6).

We saw in [Shelah and Clay of Spittle, page 7](#), that the “water tunnel” whereby Joab secured Jerusalem is a type of our entrance into the third-part Shelah/Siloam Millennial period. But equally true and very importantly, as you will see here, it is also the ability to ascend alive into Jerusalem above. The Hebrew word used here for “water tunnel” (#6794b) is the root word for the word used in Zechariah 4:12 in identifying the two “golden pipes” (#6804) that “empty the golden from themselves.” In [The Golden Image](#), we see that the golden pipes, the golden rod, the golden image, and the golden hemorrhoids all speak of the same thing – the twelfth apostle. Added to this list is the water tunnel.

When Joab went up the water tunnel to take Jebus and become the chief and commander, he revealed the work that, through law, would take the kingdom of heaven from Satan and Christianity for the Son of David, Yahshua. Again, this is done so by law, by a “Yahweh father” masculine law work, by a Joab, understanding and implementing government. That is why this man is law. It is the only way the kingdom can be taken away from Satan and restored and the Remnant ascend alive into heaven.

Thus you see why Yahweh has led us in effecting numerous legal acts. At Atonement, 2004, Yahweh had us to contractually transfer the office that Satan has had the right to for 2,000 years, to go to this man ([Legal Transfer of the Office of the Twelfth Apostle](#)). And on April 26, 1996, a proclamation was made concerning the Remnant’s legal removal from Christianity and Satan

([Proclamations of the Remnant](#)). This is also why we have gone through all of these intercessions, and far more than you or I can even be aware of, including going to Georgia in 1996 ([Cursed Time and Blessed Time](#)) that eventually cost me my family. They are all legal endeavors and requests.

This is also why Yahweh has given us the understanding of the necessity of holding all things in common as a legal covering over the glory. This is why Yahweh gave us the truth concerning the rod and entering into the Millennial reign in 2004. And most importantly, this is why Yahweh gave us the truth about the new Millennial calendar and the mirror images and the critical necessity of adding the eighth. It is all law and government, and only by law and government can the kingdom be restored.

This is also why Yahweh showed this man (who is **only** a man) that he is the twelfth apostle, standing in the office of Yahshua, and that it was critical that a last days one-and-twelve government be restored. It was absolutely critical that He showed us the Curse of 1920, and the need to restore the government of the twelve apostles with the legal prophetic testimony of reversing that Curse, as well as show us the curse that has been on the church from the outset by the establishment of the seven, and legally how to reverse it.

And very importantly, this is why Yahweh moved this man to Salem, Missouri, and then brought twelve people into this home in order to establish the twelve stones erected in the camp (Joshua 4:8), the twelve apostles. Even as Joab ascended the water tunnel so as to secure **Jerusalem**, so Yahweh secured the twelve foundation stones of Revelation 21:14 by sending twelve immensely common people to the twelfth apostle's home in **Salem**. Yahweh does all things well and governmentally, using the foolish and the weak to shame the wise and the strong.

And VERY significantly, and absolutely critical, on Atonement, October 25, Yahweh showed this man what you are about to learn – **the legal rights to ascend alive!**

The Day of Atonement is also the Day of Jubilee when all debts were released (Leviticus 25:8-12). That which we will address here specifically relates to this hope-filled promise, not only because it was revealed on the first ever acknowledged Atonement per the Millennial calendar, which is indeed significant, but because it relates to a very significant and highly revealing truth regarding our ascending alive. Let us consider this.

When the sons of Israel came to the promised land for the first time and sent in the twelve spies, it was at the time of Tabernacles, one-and-a-half years after leaving Egypt. But of even greater significance, this was not just any Tabernacles, for it was in fact the Tabernacles/Day of Atonement precisely at the Jubilee of Jubilees!

Fifty Jubilees are 50 x 49 years, or 2,450 years. As addressed in *Secrets of Time* by Steve Jones, the twelve spies were sent into the promised land in the fall of 2449 from Adam. Steve explains – “This was actually ten days into the next year, the year 2450, because the Hebrew year began in the fall” (p. 22, 1996 edition). He then goes on to say – “The point is that Israel was supposed to blow the trumpet and decide to inherit the Promised Land on the day the 12 spies gave their report. ... If Israel had chosen to inherit the land at Tabernacles of 2450, they would literally

have returned to the inheritance that they had lost in Adam – the redemption of the body (Rom. 8:23)” (p. 23). This is very important to note, and we will restate it here for emphasis – **entrance into the promised land via Tabernacles is the redemption of the body, entering into an incorruptible immortal body.** Let us hold this for now and add something else that is very important to this matter.

In John 3:13, Yahshua said – “No one has ascended into heaven, but He who descended from heaven: the Son of Man.” And in John 8:23 He also said – “You are from below, I am from above; you are of this world, I am not of this world.”

Recorded only in first Remnant Matthew 6:9-13 and second Remnant Luke 11:2-4, we find Yahshua’s prayer that included this important request:

“Your kingdom come.
Your will be done,
On earth as it is in heaven.”

We have been learning that Yahweh creates mirror images. This is true with the kingdom of heaven as well. There are actually two kingdom of heavens. There is the one which is above from which Yahshua said He had come and into which no one has yet ascended. No one has yet to enter into the first resurrection (Revelation 20:5-6) that takes man into that heaven, Jerusalem above, to be born from above and receive his incorruptible immortal body. This is the true and perfect kingdom where God dwells.

But even as there is the perfect kingdom above, so there must be a mirror image of that kingdom as well, which is the kingdom of heaven that Yahshua prayed would be established on this earth – “on earth as it is in heaven.” This is the kingdom of heaven, the garden of God, that Yahshua restored via His Nazirite vow and gave to man. But the fact is, He did so before the time, too early, creating a Saul work that could not do the will of Yahweh, even a Judas work that betrayed Him.

The timing of the true kingdom of heaven on this earth was not to come for 3,000 years. But that time had to be cut short to 2,000 years and Yahweh go ahead and effect that work today, now. This is where we are in His timing, and Passover, 2004, marked the beginning of this new Millennial kingdom on the earth.

Thus we see these two evidences of the kingdom of heaven. There is the kingdom that is above, from which the second, the earthly kingdom, is a mirror image. Even as it is written, this earthly kingdom is “a copy and shadow of the heavenly things, just as Moses was warned by God when he was to erect the tabernacle; for, ‘See,’ He says, ‘that you make all things according to the pattern which was shown you on the mountain’” (Hebrews 8:5).

So what kingdom do we truly need to enter? Both, for sure; but the greater and exceptionally more necessary kingdom to enter is that one which is above, the more perfect Jerusalem above where we must enter by ascending alive and therein receive our born-from-above incorruptible

bodies. So how is it that we can enter into that kingdom? This is an extremely important question!

Christians falsely think that any day now there will be the “rapture” and they will all be caught up in the air. Of course they have absolutely no cognizance or even the remotest understanding of the vital need for an Elijah to make possible this event and, as Yahshua said, “restore all things” (Matthew 17:11). And even as Yahshua equally said, Christians “practice lawlessness” (Matthew 7:21-23), and thereby cannot and will not ascend alive. They have absolutely NO idea what it takes to do so, being lawless; and like the two loaves (2,000 years) of leavened Pentecost bread, will not ascend to Yahweh as a burnt offering. All they can do is sell their end time books, recorded messages, videos, and seminars as moneychangers.

To begin to understand what it legally takes in order to ascend alive into the kingdom of heaven above, let us return to our testimony regarding the sons of Israel. Yahweh gives us two separate testimonies regarding entrance into the kingdom of heaven, the promised land.

1. A Tabernacles entrance at a Jubilee of Jubilees wherein that entrance would follow the sending out of the twelve.
2. A Passover entrance that is preceded by a period of wilderness wanderings, a transfer of leadership, a Jordan crossing, and the warning to stay 2,000 cubits back.

Though this may confuse you at first, these two entrances into the promised land reveal the two entrances into the two kingdom of heavens. **The Tabernacles entrance is the entrance into the kingdom of heaven that is above, while the Passover entrance is the entrance into the third-part Millennial kingdom that is on this earth.** Even as both are the kingdom of heaven, so both testimonies are related to this matter of the promised land. But the former is per the kingdom of heaven above, and the latter is per the kingdom of heaven here on earth. Let us first consider the latter of these.

It has been evidenced in other writings that the wilderness period of the sons of Israel clearly represents the period of Christianity ([Shelah and Clay of Spittle, page 3](#)). The Jordan crossing is the entrance into the Millennial reign, evidenced by the testimony of the two witnesses which in fact are the same as the two piles of twelve stones, one in the Jordan (the first Remnant twelve apostles) and one in the camp (the second Remnant twelve apostles).

It is very important to note that the fulfillment of this prophetic testimony per the Passover entrance into the promised land west of the Jordan came in 2004 when four members of the Bride met in this man’s home in Enumclaw, Washington, and shared Passover together. This marked the entrance into this third-part Millennial kingdom, the promised land, which was immediately followed by numerous incredible revelations that were presented in the writings beginning with [The Rod](#), including [Shelah and Clay of Spittle](#) that revealed this Millennial entrance.

Thus we see that our entrance into the promised third-part kingdom of heaven here on earth was indeed at Passover, fulfilling that testimony. But what about entrance into the heavenly kingdom above? What will it take in order to come to the place of effecting that vital entrance?

First, you will notice the testimony of sending out the twelve. Is that not precisely what Yahshua testified when He sent out the disciples, along with the testimony when the Levite sent out the twelve parts of his concubine ([Sending Out The Twelve](#))? Thus, in order to be able to experience this Tabernacles that leads to entrance into the heavenly kingdom above, there must be the establishment of the twelve apostles, and there are only two works that would qualify for this – the first Remnant and the second Remnant. Of course this excludes Christianity already, for they cannot provide those twelve governmental witnesses.

So did the first Remnant qualify to ascend alive into the kingdom of heaven above via their twelve? No. The fact is, when they reached a Tabernacles equally one-and-a-half years following Passover/Pentecost, they failed to enter in, even as testified by the sons of Israel. Even as the sons of Israel picked up stones to stone the true witnesses, Joshua and Caleb, so after Yahshua sent out the twelve disciples men picked up stones and stoned the true witness, Stephen. If the first Remnant were to ascend alive, it was at that Tabernacles that they would have done so; but they could not, and there was a very important legal reason for this.

We will not talk about the issue of timing here, for the fact is they could not ascend alive because it was too early. They were before the time. There had to be the breach period of the church that would follow, or in continuing type, there had to be the wilderness period of Christianity. But also, there was a legal reason they could not enter, a VERY important legal reason, critical to the second Remnant ascending alive!

The first Remnant had received the outpouring of the Holy Spirit on a regular Pentecost fifty days following Passover. We read in [Hurricane Katrina and the Curse of 1920, page 4](#), that this Pentecost is the third-part body of Passover. There are two things to consider here regarding this Pentecost. First, it is the Pentecost that is carried out with leavened bread, specifically two loaves of leavened bread. This of course speaks of the church that would follow – 2,000 years of leavened Christianity. But it is also very important to remember that this 2,000 year work is also a breach in the promise. What is the promise. In the simplest of answers, the promise is to not die but to ascend alive. This is the promise of Passover. Keep in mind that the original Passover was held for one reason and one reason only, and Passover speaks of that one thing – the ability of the first-born to escape death.

So did the first Remnant not die but ascend alive as promised by Yahshua (Luke 9:26-27, John 11:26)? No! Even as Stephen was stoned at a Tabernacles equally one-and-a-half years following Passover/Pentecost, so the first Remnant died. So did Christianity fulfill the promise of Passover and not die but ascend alive? Of course not, for they have been the promised “two parts” that have been “cut off and die” as foretold in Zechariah 13:7-9. Then can Christianity now fulfill this promise and have their “rapture”? Again, the answer is clearly no, and you will now see why.

The promise to ascend alive is given specifically to the Remnant. It was given to the first Remnant, but because they were too early and there had to be the first bird for the cleansing of the leper, they had to die and that promise would go to the second Remnant, the second bird that ascends alive (Leviticus 14:1-7). This is the same testimony seen when Zerah first extended out his hand and captured the scarlet thread, then took it back in, followed by the birth of Perez, the breach, and then came the true recipient of the right of the first-born – Zerah, the light. This is of course the second Remnant, that has the legal right of the first-born (the scarlet thread) via the brief first Remnant.

So, the first Remnant could not ascend alive, nor could or will Christianity. How is it then that the second Remnant can ascend alive, or enter into the promised land? There are two answers to this, for it is in fact the second Remnant that fulfills both attested entrances into that promised land – the earthly, as well as the heavenly.

First, we have seen that the second Remnant held a Passover in 2004 that effected the entrance into the Millennial period. Legally, how was that possible? That Passover was made possible via the Pentecost former rain. Remember, it is the fulfillment of a Pentecost that affords the associated feast a body, thus making that associated feast alive. Without that body, the associated feast is dead. As evidence of this, how can your spirit and soul function without a body? It cannot. Without a body, your spirit and soul are asleep.

When the former rain came on Pentecost, that made Passover (the Passover promise) alive.

But there was only one problem. Even though Passover was now alive and men could enter into the promised kingdom of heaven on earth, the coming of that kingdom was too early and it would be corrupted. This is what took place per that promised Passover kingdom for 2,000 years. The wilderness period of Christianity began, and it would continue until the second Remnant could effect the entrance into that promised Millennial fulfillment via the promised legal Passover entrance. This promised entrance was finally afforded on Passover, 2004. Thus, at the earthly level, the kingdom of heaven could finally be legally entered via the fulfillment of the promise by the second Remnant.

You may say – But there has been no observable change to the earth. There was no visible change to the earth when the Son of God was born either; but it marked a beginning that would change the earth. Such is the case with what the second Remnant effected as well. What took place on Passover, 2004, marked the beginning of dramatic effectual changes to come; but they must be worked out. As has been noted, what was not legally possible before that all-important Passover, is now possible, now legal.

Thus we see the final fulfillment of adding the former-rain body to Passover – the entrance of the second Remnant into the Millennial reign fulfillment of the kingdom of heaven at the earthly level. But, how then can man gain entrance into the kingdom of heaven above and have the legal right to ascend alive? The second Remnant finally effected the beginning of the Millennial reign kingdom of heaven, and it is the second Remnant alone who have been given the authority and thus the understanding of how this must equally be accomplished – **once again by adding the all important eighth!**

Yahweh has in His government certain feast days that He calls “holy convocations.” These are special feast days in which the people are commanded to gather together and no work can be performed. They are sabbaths, days of rest. Let us count the number of these holy convocations.

First, there are the holy convocations of Passover and the last day of Unleavened Bread, for a total of two. Then there is the holy convocation of Pentecost, for a total of three. In the fall feasts, there are the holy convocations of Trumpets, Atonement, the first day of Tabernacles, and then the added last great eighth day of Tabernacles. These four added to the three in the spring feasts totals seven, the mark of the beast! **As long as there are only these seven holy convocations, the feasts can only lead to a curse and death, which they have clearly done thus far.** So what, once again, is the solution? Very simple – add the all important eighth! All that has to be done to reverse the curse on the feasts in their shortfall state is to add an eighth holy convocation. And how is this done? Very importantly – **by giving Tabernacles a body, by adding the Tabernacles Pentecost!**

As presented in [*Hurricane Katrina and the Curse of 1920, page 4*](#), Tabernacles without a Pentecost is dead. This is why Tabernacles up to now has never been able to effect anyone to ascend alive, not even the first Remnant. They received the former rain on a Passover Pentecost, giving Passover a body and allowing the second Remnant to cross the Jordan and enter into the promised land Millennial period of the kingdom of heaven on earth. But at that time Tabernacles was still dead, having no body; so when they came up to the place of entering into the kingdom of heaven above when Stephen gave the true witness, they could not ascend alive. All they received was Stephen’s witness of seeing Yahshua standing at the right hand of the Father (Acts 7:56), and they then entered into the breach, the wilderness.

So what then will it take to ascend alive? We have already seen the critical necessity of being able to send out the twelve. As of Trumpets, 2005, we now have the ability to do this, Yahweh having established the last days twelve apostles. But there is another critical element that must take place as well – **there must be the addition of the vital eighth holy convocation. Tabernacles must have a body, a Pentecost!**

Herein lies the critical legal difference that sets the Remnant Bride apart from Christianity, or any religion that seeks to enter into heaven – they are given the ability to ruminate and to see things no other man has ever seen, to see truth and government that will literally set them free from this earth. They are given the ability to both see the need for and have the authority to establish a body for Tabernacles by celebrating in the Millennial reign under the new Millennial calendar for the first time a Tabernacles Pentecost. This is done so through the legal means provided by Yahweh’s established laws and government, and will take place for the first time on December 25-26, 2005 – the test of Carmel!

By adding this feast, this eighth holy convocation, Tabernacles Pentecost accomplishes for Tabernacles what Pentecost did for Passover – it legally engages it, it makes it alive and thus effectual! In reality, it makes it possible for Tabernacles to take a people into the promised land at the heavenly level, to ascend alive, fulfilling that which was foreshadowed when the sons of Israel first came up to the promised land but could not enter in because of unbelief. What the first Remnant could not do because their outpouring was on a Passover Pentecost, the second

Remnant can do because their appointed outpouring will be on a Tabernacles Pentecost, **giving Tabernacles the much needed body, adding the essential eighth, and making Tabernacles alive and now legally effectual in its appointed purpose – to afford men entrance into the heavenly kingdom of heaven from which Yahshua came. This is the promised and foreshadowed and much needed Jubilee of Jubilees!**

For some, you may think this to be too complex. That is OK. When you get on an airplane to fly somewhere, you are not required to have a knowledge of how the plane works. All you have to do is get onboard. But you can be sure, someone needs to know very well how that plane works, and can keep it working correctly. What you just read is critical to understand for those who are responsible to get this Bride, by Yahweh's grace, to where it has to be; and it is for those whom this information is provided (as well as for those who love to learn and marvel at what Yahweh is doing). So for you who get onboard, as stated by Tank in the highly prophetic movie, [The Matrix](#), when the crew was going into the Matrix to see Oracle – “Everyone please observe: the fasten seatbelt and no smoking signs have been turned on; sit back and enjoy your (flight).”

ADDING THE EIGHTH

It is incredible how significant this principle of adding the eighth is proving to be. Let us list some of them.

- Adding the eighth trip up Mount Sinai reversed the curse of Yahweh not going with the sons of Israel and killing them if He did.
- Adding the eighth day of cleansing for the healed leper made it possible for him to return to his tent (Leviticus 14:9-20).
- Adding the eighth son of Jesse to those presented to Samuel delivered the people from the curse of having premature Saul to rule over them.
- Adding the eighth President, Reagan, to the string of seven Presidents who died in office when elected every twenty years, reversed that curse of death.
- Adding the eighth holy convocation via a Tabernacles Pentecost reverses the equal curse of death on those days and allows the second Remnant to ascend alive.
- Adding an eighth man (Kyle) to the mark-of-the-beast seven established by the eleven reversed the curse that has been on the church from its beginning.
- Adding an eighth person (Kyle) to the seven who represented the Curse of 1920 (on the one-year anniversary of the Red Sox World Series win), reversed that curse.

And speaking of the testimony of the eighth and the World Series, what is the chance that after the highly prophetic [2004 World Series win](#) by the 1920 cursed Red Sox, the equally 1920

cursed White Sox would win the 2005 World Series? And most significantly (like unto the odds that seven Presidents would die in office every twenty years, but not the eighth), the Red Sox set a World Series record by winning eight games straight, which was matched the next year by the White Sox! Since both of these teams were under a curse originating specifically in 1920, and both teams won historic eight games straight, and both are "Sox," do you think Yahweh might be saying something? Obviously so! As reported in an article on Fox Sports on October 21, just the odds of these two successive victories was 1 in 18.1 million! Add to that that both teams testified of the same World Series record of eight straight wins, the odds would be off the chart! Clearly, Yahweh speaks from a whirlwind; do you think He speaks from a baseball diamond as well? He is God, and there is none like Him!

Here is the Fox News article that was written the day before the World Series:

Before we look at the respective ballclubs, let's take a look at some of the numbers that come into play as the Series gets set to open. The White Sox, as already mentioned, last won the Series in 1917. Two years later, in 1919, a team considered perhaps the best of its time, was upset by the Cincinnati Reds. A year later, following the 1920 season, eight members of that team, including the great "Shoeless" Joe Jackson, were banned from baseball for conspiring with gamblers to throw the World Series. Forever after, that team and those players became known as the Black Sox. Could that be the White Sox's curse? The Pale Hose last made it to the Series back in 1959. That ballclub, known as the "Go-Go" Sox for their speed, lost to the Dodgers. The Sox haven't been back in the 46 years since.

As for the Astros, they played their first season as an expansion club in 1962 after being born a year earlier, and were known then as the Houston Colt 45's. So the team has been in existence for 44 years and has never made it to the Series.

Then you look at the guy who pitched the pennant clincher for the Astros. Roy Oswalt wears No. 44, and was the MVP of the NLCS. The team leader, Roger Clemens, wears No. 22 which, of course, is 44 divided by two. And for most of the season he's pitched as if he was 22. Is there any significance to that? The day Roger's beloved mother died earlier this year she told her son to go ahead and pitch, and then supposedly predicted the final score that day would be 10-2. It was. And one of the last things she allegedly said was that she had a vision of none other than Shoeless Joe Jackson, the ill-fated Chicago White Sox star. Were these two teams destined to meet all along? Why not look at it this way and have some fun?

Here was Clemens' statement:

"This is momma, she was thinking baseball. She came to and asked if we were in the playoffs yet," Clemens said. "Out of nowhere came, she mentioned Shoeless Joe Jackson. It was unbelievable. ... I asked her if she was in the fields, and she said, 'I think I am.' She just loves the game."

In 1920, two baseball curses were effected – the Red Sox sold Babe Ruth to the Yankees, and eight men from the White Sox were banished from baseball, including Shoeless Joe Jackson, the eighth (who is regarded to this day by many to be innocent). Shoeless Joe has become a household name from the very popular movie, *Field of Dreams*, which is highly prophetic. Let us briefly consider the testimony of that movie in light of this most incredible World Series win.

“Build it and he will come.”

This statement was the foundation message of that movie. What did it mean at the outset? If Ray (as in a ray of light, or the Luke/light second Remnant) would build a baseball field, Shoeless Joe Jackson would come. Of course the idea was entirely crazy to him; but within Ray, despite what it looked like in the natural, he knew he had to build that field, and he did. That summer he plowed under his corn and built the baseball field, while the scoffers stood by and ridiculed him.

Did Shoeless Joe come? No. Winter came and there was no Joe. The next year Ray planted his corn, less the baseball field, driving him into bankruptcy. He looked like a total failure, and was doomed to such. (Here again, as addressed in [Hurricane Katrina and the Curse of 1920](#), we see the testimony of a one year delay.) But it was at that time of apparent defeat and desperation that Shoeless Joe did come – first just Joe, then the other seven who were banished, and then enough for two teams. (Of course who couldn't see, but Mark – Christianity.)

Do you see the clear prophetic message once again? “If you build it he will come.” Who will come? The all-important redeeming eighth, the one who redeems the seven! SO, this “Ray” built a baseball field, the kingdom of heaven, despite all the scoffings and jeers and the appearance of failure, and the all-important eighth did come – Kyle Nixon, an avid baseball fan. Kyle came as the eighth and redeemed the seven – first the seven who represented the Curse of 1920, and then the seven who were established by the eleven apostles. The very message prophesied in *Field of Dreams*, was fulfilled at a very critical level at Trumpets, 2005.

And even as prophesied by Shoeless Joe, we too had taken off our sandals, our shoes. The work that Yahweh performed at that gathering was His work; we simply walked out what we saw Him performing. That which was prophesied per Shoeless Joe's name, that which was prophesied by Joshua equally being told by the captain of Yahweh's host to remove his shoes upon entering into the prophetic Shelah Millennial reign period, was effected on Trumpets, 2005, when Yahweh set up the twelve apostles. We had our shoes off, and He did the work.

But frankly, while the establishment of the twelve is a critical and essential step, it is not the end of this prophecy. “Build it and he will come.” In the movie, we saw an unfolding of that message that did not end with just Shoeless Joe, but in greater fulfillment Ray's father came. Who is it that we truly need to come? Is it not the Son of God? And when was He legally supposed to come? On the eighth “day,” the eighth Millennium, which is the first day of the following “week,” the day that divine light was created in the beginning.

The eighth that we must have is the coming of the Son of God. By adding this eighth early, stacking the eighth on the seventh, truly all curses will be reversed at a much higher level. What

we/Yahweh did here at Trumpets, 2005, was a much needed intercession and fulfillment; but it also points to a fulfillment that is at hand. Yahweh led us through a type of that which is to be, and as intercessors, we tapped into the same power as the return of the Son of God, but at a lower level, though still critically important. So let us add yet one more culminating and even ultimate testimony to this matter of adding the eighth:

- Yahshua, who was supposed to come on the eighth Millennium, comes on the seventh, adding the eighth early so as to redeem the mark-of-the-beast 7 and reverse the curse on the earth!

With this incredible testimony and fulfillment taking place on October 16-17, what are the statistical chances that while we were gathering for Trumpets and adding the eighth, the White Sox began their string of record eight wins, winning the League Championship on Trumpets, October 16, the first four of those eight, and giving testimony to this very thing we are seeing here – adding the all-important eighth? Again, this is as far beyond the realm of statistical probability, as it is that seven Presidents of the United States would die in office every seven years, and the eighth would defeat death! At some point, unbelief must yield to reality.

But let us add even more evidence to this obvious testimony. In the first game of the 2005 World Series, the White Sox won with a score of 5 to 3, for a total of eight, setting forth at the beginning the clear prophetic testimony of the eighth. The next night, they won 7 to 6, for a total of thirteen, or the one-and-twelve government. There was also a testimony in this game that was exceptionally encouraging to this man. At the bottom of the ninth, the score was tied 6 – 6 (the twelve), with the White Sox at bat. Podsednik stepped up to the plate with one of the lower batting averages on the team, and had not hit a home run the entire regular season. “I don’t think anyone in the ballpark was thinking I’d hit one out,” said Podsednik later. Indeed, no one suspected that he would hit the home run that gave the White Sox that second win, providing the important testimony of the thirteenth.

Personally, this was very encouraging because this man had the identical unforgettable experience on a grade school playground, where they jeered me that I could not hit the ball; and they were right. In like prophetic foreshadowing, no one was suspecting I would hit a home run either; but I did, equally winning the game and touching the home plate as the schoolhouse bell rang. Is this man capable; is he an applauded and recognized success? No. He is unsuspecting, unassuming, and weak. But, he stands in an office as the thirteenth that is added to the twelve, and he will secure the victory by Yahweh’s equipping grace. It will be a home run!

In the third game another World Series record was set – the longest World Series in baseball history, tying the number of innings when in 1916 the Red Sox pitcher, Babe Ruth, went 14 innings, affording yet another tie to the Red Sox and Babe Ruth. Frankly, based on the Red Sox wins the year before, I told Kyle prior to the game that I thought the White Sox would take an early lead and it would be an easy win; but obviously it was not. Where did I error? Afterwards I realized my error was in comparing them with the relative ease of victory by the Red Sox in one of their games.

The Red Sox in one regard were in type the first Remnant – the first bird that is killed in Leviticus 14:1-7. The White Sox were the second bird – the one that ascends alive and does not die. While the first Remnant had it relatively easy per receiving the former rain, tarrying only seven days, the second Remnant has tarried eleven years with many difficult intercessions. Thus, what I thought was to be an easy game, was very difficult, much in the same way as at the beginning when I thought the Remnant work would be easy, but has been very difficult. “You have asked a hard thing,” said Elijah to Elisha (2 Kings 2:10). It has not been easy, and like that long and arduous third game won by the White Sox in weakness via many walks and the Astros on the bases, it has often appeared that we would fail.

It is also relevant and quite noteworthy per this third game that the Remnant Bride likewise had to have time (innings) extended into the third Millennium in order to effect victory – sending the blind man into the Siloam/Shelah Millennial period with clay of spittle on his eyes so as to have his eyes opened ([Shelah and Clay of Spittle](#)). The final score was 7 to 5, totaling the number of elders – 12.

And while we are comparing here the Red and White Sox, you will notice that the characterization of them per the term “sox” can imply having one’s shoes removed, even a Shoeless Joe, taking off one’s sandals and Yahweh performing the work. This is obviously the case per these last two World Series wherein the curses of 1920 were reversed in most spectacular and revealing and confirming ways, types of what is ahead for the Bride and mankind. It can also be said that these two successive replicated wins represent a double portion of the outpouring of the Spirit, the latter rain.

Thus we see three games with incredibly prophetic scores, and the fourth and final was no exception. While the first game testified to the all-important eighth, from what inning in this fourth and final game was the World Series Championship given to them? In the **eighth!** The final score of that fourth game was 1-0, and was won by a single run in the eighth inning! Thus we could add:

- Adding a run in the eighth inning of the last game of the World Series reversed the curse of 1920 on the White Sox.

In further testimony regarding this matter of the eighth, there is the sure **victory** that the eighth affords per the “red eight” as presented in the writing [Shelah and Clay of Spittle, page 4](#). That writing was written in 2004, yet today we see the same truth, but in a much fuller manner. It is quite encouraging to see that what Yahweh is revealing to us today, was the same thing He was beginning to reveal to us a year ago. Yahweh is performing this work, and this is just one more testimony that the Holy Spirit is the one who is leading us into all truth, and this truth is once again seen as this seamless garment. Everything we are learning today has been consistently unfolding over the last few years, and this significance of the eighth is no exception.

What does the red eight thus promise? **VICTORY!** Much needed victory!

With such incredible events as the Red Sox win, followed by the White Sox win, and all that is associated with these per the eighth; with the highly prophetic movie, Field of Dreams, and the

testimony of the eighth; with seven Presidents dying in office every twenty years and the eighth defeating death; and even with Kyle being a “red eight”; creation is crying out to us – Add the eighth! Creation longs to be delivered from the curse it has been under, and if we have ears to hear their message, we can listen to their cry and respond.

Let us now consider yet another highly revealing testimony regarding adding the eighth. In December, 2004, Yahweh used a set of circumstances to lead me to go to a bar/tavern for seven successive Saturdays for the specific purpose of finding the Bride. You undoubtedly will think this very strange, but that is precisely what He had me to do. On the first Saturday, January 8, Kyle took me to an Irish pub in Seattle. (Kyle used to own a tavern, and it was my first time to enter one, other than in a brief trip to Ireland.) The next three Saturdays I went to different taverns in Enumclaw, where I lived, drinking a Guinness and just talking to a few people. The next two Saturdays, I went to the same tavern and found some very common, down to earth people whom I enjoyed very much.

But the timing of these specified seven visits was such that on the seventh Saturday, I was in the home of Jim Neumann, outside of Salem, Missouri. You can read about Jim in the writing, [Response to Authority, page 4](#). I received an e-mail for the first time from Jim on February 2; seven days later I had a ticket to fly to his home; and seven days after that I was in his home. The last evening of our visit was the seventh Saturday.

I realized that Jim was my “bride,” evidenced by this seventh visit in which I was to go to a bar, along with numerous other testimonies. From that visit, we held our 2005 Passover gathering in his home; and during that time he invited me to move there and live in their home. After returning to Enumclaw, I realized this move was indeed Yahweh’s will, and began making plans for it. But as it unfolded, it became clear that I was not to move into Jim’s home, but to have my own place there.

Arriving on August 31, exactly eleven years from when my family and I moved to Washington state, I spent the next two days looking at housing that might be available; and immediately after refusing to hurt someone else per a home that was available to me, Yahweh led me to the home where I live at the time of this writing – 411 E Franklin #1, in Salem.

Because of the truth Yahweh revealed to us about the new calendar and Tabernacles Pentecost, we scheduled the gathering for Trumpets, October 16-17. That event was once again supposed to have been in Jim’s home; but only days before, he backed out entirely and it was held in my home. Here Yahweh performed the incredibly significant work of establishing the twelve apostles, and of course Jim was not one of them. So what can all of this most incredible set of events mean?

Here again we find the seven-and-one pattern. What was the specified purpose for the seven visits to the bars, the seventh in fact being in Jim’s home? They were to provide me a Bride. Yahweh showed me that Jim was my bride; but did that turn out to be the case? No. Yes, it was revealed in clear testimony and even promised, but it was the mark-of-the-beast seven and had to fail. The seven is a shortfall, something that leads to the true fulfillment, and may even have the

promise, but it must die! Thus, Jim's fulfillment as my bride had to die, and he rejected me as the twelfth apostle, therefore rejecting me as his husband.

But all of this was essential, for no one man could be my Bride. This man stands in the office of Yahshua, and His Bride is a company of people. This is the Bride this man had to receive in His place. **Thus, on October 16 I received the Bride – the establishment of the twelve apostles, a legal representation of the whole that will come.**

Let us consider another unmistakable testimony of this company being my Bride. As has been noted before, there were five eruptions on Mount St Helens following the initial eruption on May 18, 1980. In [A Lesson From Intercession, page 8](#), we note that the eruption of Mount St. Helens affords a prophetic picture of the latter rain. When it blew on a Sunday, May 18, during the month that Pentecost can fall (Pentecost was one week later), its unexpected explosion caused Spirit Lake to be raised 200 feet and double in size. Thus, it was a testimony of the latter rain that comes 2,000 years later and is a double portion of the Spirit. (Pentecost actually falling the following week, identifies this as being the like but separate Tabernacles Pentecost that has now been revealed.)

The five successive eruptions that occurred afterwards were on May 25, June 12, July 22, August 7, and October 16. As pointed out, patternwise, May 25 and June 12 represented the first Remnant. Reports regarding the center July 22 eruption revealed a concern that Spirit Lake would breach, thus testifying to the breach of Christianity that separates the two Remnant. The last two eruptions would thus represent the second Remnant. And as has been noted, August 7 is this man's birthday, and October 16 is my wife's birthday. What are the chances of that being the case? When it comes to prophecy, it is a 100% chance.

As the October 16 Trumpets approached, Yahweh put upon me an intercession for what I thought was for my wife, my natural bride. It was on August 7, 1994, that this man was born into the Bride, when Yahweh showed me I was false Remnant and had me to give up everything and move to Washington state. Thus, it was my expressed hope that on October 16, 2005, my wife would believe and be born into the Bride as well. But even as Jim was not to be my Bride, neither was my wife to be the provision on that extremely significant day.

On October 16, my bride was born into the Remnant, but it was the MUCH more important Bride of the twelve apostles. Afterwards I realized that, **as prophesied by these latter two eruptions on Mount St Helens, on August 7, 1994, it was not just that I was born into the Bride, but that Elijah was born. Then on October 16, 2005, the Bride was born with the establishment of the twelve apostles. Now we know the significance of these amazing dates.**

The question arises here – Why would Yahweh precede the establishment of the twelve apostles with such an unusual set of circumstances? There are many reasons, but it is important to note that Yahweh operates via intercessions, patterns, and government. Yahweh is lawful, and rejects those who are not (Matthew 7:21-23). This is the very reason we are able to see beforehand the great significance of the Tabernacles Pentecost, and to seek its observance. Also, as an intercessor, I had to step into the place of having the legal right to the Bride, receiving her by faith – hearing, believing, and acting. Seven Saturdays in a tavern; moving to Missouri, leaving

everything I had known for eleven years, including my family and Alzheimer mom; finding a home; even calling a gathering at Trumpets; all meant walking in faith.

By having this man to go into a tavern for seven Saturdays, and on the seventh Saturday to find Jim Neumann, He was attesting to the number 7 mark-of-the-beast period of Christianity that precedes the establishment of the Remnant Bride, the all-important eighth, evidenced by the establishment of the twelve apostles. Yahweh works according to patterns, and the establishment of the twelve was fulfilled per a very relevant pattern that this man, the twelfth apostle, had to walk out in complete faith. Yahweh works according to patterns, and He works these through and for men and women; and He used this to evidence and bring about what He is doing today – rejecting Christianity, and establishing a Bride.

Thus, let us note here the testimony that adding the Bride is once again this all-important addition of the eighth, this time to mark-of-the-beast-seven Christianity, reversing the curse on the church. Even as Yahweh added the twelve apostles as my Bride on Trumpets, October 16, following the shortfall Bride testimony of Jim as the seventh; and even as adding the eighth, David, removed the curse of Saul; so:

- Adding the eighth work to the church, the redeeming Remnant Bride, removes the curse off the church.

Now for a matter that some might find confusing or offensive, and some will find very encouraging, confirming, and convicting. But it is true, and is equally revealed per this matter of Jim. We are going to think governmentally here and not emotionally, looking at man's existence from the bigger picture. Again, try to think governmentally.

Jim represented something or someone that occupies a **temporary place**. That place, though critical, is temporary and foreshadows that which is to come. Not only does it foreshadow, but it also gets us to the place where we are to be, i.e., to the true fulfillment. It is in this regard an Elijah, which occupies a place until the perfect comes, preparing the way. When the perfect draws near, it then decreases and eventually passes from that place, as the perfect increases to take full possession. This is an important principle per this position.

This was the role of Judas. He was a temporary fulfillment of him who was to be, a foreshadowing of the one to whom the office truly belonged – the last days twelfth apostle. What about Satan in his role in that office? He too was a Judas, and he fulfilled his place as such by baptizing the body of Christ into death, and equally preserving that vital office until today.

There is a writing titled [*The Passing Over Principle*](#), and in it we see that Yahweh has a way in which He passes over the first, then passes over the second, and takes the third. This is precisely what He did per this office – passing over Judas, passing over Satan, and taking the third. But it is also true that sometime there is but one passing over. For example, Yahweh passed over Ishmael and took Isaac, and He passed over Esau and took Jacob, and He passes over the body of Christ and takes the Bride.

While there is the testimony of Satan being the second passing over, he was unique in that he was a spiritual being, and the other two were/are mere men. Thus, per these two men, we see a passing over of the former and the establishment of the latter. This is a way of Yahweh, and you will be surprised at how this “Judas” principle finds its application in man.

In this pattern per a Bride for this man, Jim occupied the Judas position. He was a shortfall type of the Bride that was to be, but could not be the fulfillment. In like regard he occupied the critical place as the Elijah, which is the Judas ministry, preparing the way for my true Bride – the twelve. Yahweh used Jim to get me to Salem, Missouri, even to call the Trumpets gathering, and then in a backhanded way to get the twelve apostles into my home, under my governmental place. (In like manner, my family has been used in a backhanded way to get me to the Bride.)

Most of the things in our lives right now are Judases. They are not eternal, but occupy a natural place that waits to be filled by that to which that place truly belongs – the eternal fulfillment. Paul said in 1 Corinthians 7:31 – “the form of this world is passing away.” More specifically, he related this to the period when “time has been shortened” (vs. 29). In Paul’s time, and even over the last 2,000 years, time has never been shortened, and what he said here applied to another day when time would be cut short. That time is now, and what Paul said here will be fulfilled today!

In Matthew 24:22 and Mark 13:20 we read – “Unless those days had been cut short, no flesh would have been saved; but for the sake of the elect (the Remnant) those days will be cut short.” That is what is happening right now. The 3,000 years given to Christianity have been cut short to 2,000 years, and what Paul wrote in 1 Corinthians 7:29-31 will now be fulfilled. Let us read what he wrote.

But this I say, brethren, the time has been shortened, so that from now on both those who have wives should be as though they had none; and those who weep, as though they did not weep; and those who rejoice, as though they did not rejoice; and those who buy, as though they did not possess; and those who use the world, as though they did not make full use of it; for the form of this world is passing away.

Why is it that this is so relevant to today, other than time has been cut short? Because the Judases in our lives are getting ready to give way to those to which their places belong, the form of this world soon passing away. And what does this mean? For one, if you are the Bride, your body that has been a Judas will pass away, and that incorruptible body which truly belongs to you will take its place. It means that money and possessions that have been the necessary Judas in your life, will give way to the Holy Spirit in your life. And yes, even as Paul references first here, that family that has been given to you in this world, will likewise pass away and you will receive the family that they foreshadowed.

As disturbing as it may seem for some, your family is just as much a Judas as is your earthly body. Family ties as we know them on this earth will not exist in the resurrection. They occupy a place now, but that place too will yield to the eternal. This may be hard for some to accept right now, yet for others the shortfall Judas nature of the family is all too painful a reality; but families as we know them now are only temporary. Yahshua said that marriages do not exist in the resurrection (Matthew 22:24-30), and in Luke 8:21 He said to those who told Him that his

mother and brothers were calling for Him – “My mother and My brothers are these who hear the word of God and do it” – and He did not go to them.

Quote other passages as you may to uphold devotion to the natural family, or even follow the false ideology of the Mormons who say that the natural family is eternal, but you cannot deny this clear message from Yahshua, and Paul, and its unique relevance to this day when time has indeed been shortened. Yahshua said:

“If anyone comes to Me, and does not hate his own father and mother and wife and children and brothers and sisters, yes, and even his own life, he cannot be My disciple” (exclusively second Remnant Luke 14:26).

To the man who wanted to go back and bury his father, He said:

“Follow Me, and allow the dead to bury their own dead,” as recorded in first Remnant Matthew 8:21-22 and second Remnant Luke 9:59-60; but unique to second Remnant Luke 9:59-60 it significantly adds – “but as for you, go and proclaim everywhere the kingdom of God.”

This is the hope of the second Remnant following our December 25-26 Tabernacles Pentecost, and will mean leaving everything and everyone behind. And to another man who said he wanted to follow Him, but first wanted to go and say good-bye to those at home, Yahshua said:

“No one, after putting his hand to the plow and looking back, is worthy of the kingdom of God” (exclusively in second Remnant Luke 9:61-62).

Also in Luke 18:29-30 He said:

Truly I say to you, there is no one who has left house or wife or brothers or parents or children, for the sake of the kingdom of God, who will not receive many times as much at this time and in the age to come, eternal life.”

This passage is also found in first Remnant Matthew 19:29 and Christianity Mark 10:29-30, but unique to Luke 18:29-30 is the addition of the wife in this list (per the older manuscripts used in the NAS and RSV). Also, unique to Mark 10:29-30 it is added – “along with persecutions.”

In Luke 20:34-36 Yahshua clearly stated:

“The sons of this age marry and are given in marriage, but those who are considered worthy to attain (1) to that age and (2) the resurrection from the dead, neither marry nor are given in marriage; for they cannot even die anymore, because they are like angels, and are sons of God, being sons of the resurrection.”

There are specifically two matters/requirements addressed here:

- (1) A specific age, and
- (2) The resurrection from the dead.

First, what age is being spoken of here? Per the first resurrection, it is the age we are in right now – the Millennial reign. And those who are considered worthy in this age will be in the first resurrection – the resurrection of the first Remnant who are dead, and the ascending alive of the second Remnant who “remain until the coming of the Lord” (1 Thessalonians 4:15-18).

So if we, the Bride, are indeed worthy to “attain to (this) age and the resurrection from the dead,” why is it that we should, or even would, be wrapped up in the ways of “the sons of (the age of Christianity who) marry and are given in marriage”? Paul said regarding this age – “those who have wives should be as though they had none.” And for many of the Bride members now, Yahweh has already made that quite realistic.

The day in which we now live is as relevant and vital and challenging and fulfilling, as the day when Yahshua walked on this earth and in the year-and-a-half following per the first Remnant. Choices will have to be made today that have not had to be made for 2,000 years, for Judases are getting ready to give way to the rightful heirs – the resurrection.

This man has had to die to his family, which for a long time was a Judas to me. Though still legally married and having children on this earth, since October 16 they are essentially dead to me. This may surprise you, but this is precisely what Paul said – “from now on both those who have wives should be as though they had none; ... for the form of this world is passing away.” After what I have gone through per my family, and what I gained on October 16, my desires are not the same for my family, for I know that they are temporary, a Judas. But instead, my desire is for the eternal Bride and for their place in the kingdom of heaven. As Yahshua said, I have not therein lost a family, but I have gained “many times as much at this time, and in the age to come, eternal life.”

By way of another testimony of this temporary Judas place, the same promise and failure evidenced in Jim and in my family came when Yahweh told me to take Rebekah with me when I traveled per the Remnant Bride. You can read about this at [A Lesson From Intercession, page 8](#). First, my literal Rebekah failed in both physical strength and faithfulness, then her intercessor, Kyle, failed as well. But the fact was that neither of them, being natural, could fill that position, for it had a higher spiritual fulfillment – the Jerusalem above Rebekah who lets the curse be on her (Genesis 27:13).

I now see the things of this world as being what they are – Judases, temporary occupants of a place that in wonderful fulfillment is to be given to another. And it is that ultimate fulfillment that is more and more gaining my attention, and “the form of this world is passing away” in my desires and pursuits. Why? Because time has now been cut short and Yahweh is performing a new thing – the first resurrection.

If we hold onto these natural Judases, we will remain here with them at the first resurrection. They will become anchors that will hold us here to this earth. This is the same regarding

Christianity. It too is a Judas and is passing away. And even as we have to come out of Christianity, mystery Babylon, so we will have to come out of other Judases in our lives as well.

When Judas came to realize his failures, he cast into the temple the thirty pieces of silver wherewith he had betrayed Yahshua. Today, we will have to do likewise, casting into the temple our wealth and the natural things of this world wherewith we too have betrayed Him. “See yourself!” was the answer given to Judas when he brought back the money (Matthew 27:4). How much more do we today need to hear that message as Yahweh reveals to us what we, and all we have, really are – “See yourself!” We are Judases who need to repent.

It is not the natural that we need now as we have entered into the Millennial reign; it is the spiritual, replacing the natural, fulfilling that which we see in the natural, which disappoints us and ultimately fails us. The fact is, all natural creation, the whole world, is a Judas. No matter how wonderful something or someone may be in this natural, eventually it/they will fail – if not in life, then in death. I once had the perfect family, but they all failed me. But the spiritual will never fail, for it is eternal. The natural is not; it is death and failure. Though the natural may be a critical Elijah and get us to the place where we need to be, in the end it must decrease and the perfect increase. And as we saw in the testimony concerning Jim, the true fulfillment is the addition of the all-important redeeming eighth that reverses the curse.

EVEN THE BARREN GIVE BIRTH TO SEVEN

There were seven women in the Bible who were barren – Sarah, Rebekah, Rachel, Samson’s mother, Hannah, Michal, and Elisabeth. One of those seven, Hannah, prayed/prophesied:

“Those who were full hire themselves out for bread,
But those who were hungry cease to hunger.
Even the barren give birth to seven,
But she who has many children languishes” (1 Samuel 2:5).

Did these seven barren women give birth to seven? Before answering this, let us note something very important and confirming regarding these seven women. We already know that the number seven has with it the testimony of a curse; and the way to reverse that curse is to add the eighth. So did Yahweh add an eighth to these barren women? Indeed He did, for the one who was barren and needed most to have a child, far more than any of these seven, was Mary. Mary could not have a child either, because she was not married. But of all women who ever lived on this earth, she needed to bring forth a child – Yahshua – and did so! In affirming testimony, the last three of these now-bearing women, Samson’s mother, Hannah, and Elisabeth, gave birth to sons who were each under the Nazirite vow; and Yahshua placed himself under that vow at the Passover meal before His crucifixion. Thus, Mary was the redeeming eighth, being added to the barren seven.

But back to our question – Did these seven barren women give birth to seven? No, they did not. Upon Yahweh opening their wombs, each of these women had sons of notoriety. Sarah had one child (Isaac), Rebekah had two (Esau and Jacob), Rachel had two as well (Joseph and Benjamin), and Samson’s mother had one. Hannah had one (Samuel), Michal had none, and Elisabeth had one (John the Baptist). Thus, $1 + 2 + 2 + 1 + 1 + 0 + 1 = \text{eight!}$

When Hannah prophesied this about the seven, as the fifth barren woman she did indeed give birth to the seventh; the barren did give birth to seven. But there were more barren to follow, and this is where the prophecy continues and brings much needed deliverance and further critical and very encouraging prophetic testimony.

The passage prophesies that the barren would have seven; so why then eight? For the same reason as the need to add Mary, the eighth – to redeem the seven! For the same reason it is equally recorded that Jesse had seven sons, but when it came time to reverse the curse of Saul, Yahweh added the critical eighth – David! When Michal did not have children because she mocked David (the eighth) as he danced before the returning ark of the covenant, that number stopped at seven, the curse. So who was it who reversed the curse? The redeeming eighth – the Elijah, John the Baptist, born by Elisabeth, the seventh. Of course this would make Yahshua the completing ninth. And quite noteworthy, “Elisabeth” means “God of the seven” or “God of the oath.”

Even as we have seen testified before, it is the Elijah, the Bride, that is the eighth (the ninth stacked on the eighth), added to cursed mark-of-the-beast-seven Christianity. Thus we see yet two more incredible testimonies of the critical addition of the eighth – Mary and John the Baptist.

Now let us take this one step further. It is noted above that these sons per the opening of the womb were sons of notoriety. Sarah, Rebekah, Rachel, Samson’s mother, and Elisabeth each had no other offspring. But we read in 1 Samuel 2:21 that after Samuel was born and given to Eli, Yahweh gave Hannah three more sons and two daughters, the names of which were never stated; they were simply enumerated. If you then add these five to the eight, this would total thirteen, which is of course the number of the one-and-twelve government. But what makes this even more amazing and encouraging and even prophetic, is that this specifically matches the fulfillment of the latter rain twelve apostles – **ten men and two women, plus the twelfth apostle, a man!**

From the beginning Yahweh has known these latter rain thirteen individuals; they are not happenstance! As testified here, that which is impossible with man in his barrenness in bringing forth the fruit of the kingdom, is possible with Yahweh. He has brought forth the latter rain one-and-twelve government, as testified in this living parable concerning the offspring of these seven barren women – **ten men and two women, plus the thirteenth, the twelfth apostle, a man!**

It is also worthy of noting that eight of the thirteen (or the twelve apostles and this man) were present at the 2005 Passover gathering, and the other five were added at the Trumpets gathering. This of course followed the same offspring-of-the-barren-women pattern of $8 + 5 = 13$.

This amazing choice of the latter rain twelve who were known beforehand, is echoed in Millennial kingdom John 15:16, where Yahshua said concerning the apostles:

“You did not choose Me but I chose you, and appointed you that you should go and bear fruit, and that your fruit should remain; that whatever you ask of the Father in My Name He may give to you.”

And unique to second Remnant Luke 6:12-13, we read that Yahshua “went off to the mountain to pray, and He spent the whole night in prayer to God. And when day came, He called His disciples to Him and chose twelve of them, whom He also named apostles.” Thus we see revealed here that Yahshua has spent the last 2,000 years of darkness, “when no man can work” (John 9:4), on the mountain, in heaven, praying; and now that daylight has come, He has come down in a man and chosen His twelve apostles. Again, this highly revealing account is found only in second Remnant Luke.

In 1 Samuel 2:5 we read:

“Even the barren give birth to seven,
But she who has many children languishes (diminishes).”

The latter part of this verse is equally stated in Isaiah 54:1, which Paul quoted in Galatians 4:27.

"Shout for joy, O barren one, you who have borne no child;
Break forth into joyful shouting and cry aloud, you who have not travailed;
For the sons of the desolate one will be more numerous
Than the sons of the married woman," says Yahweh.

Paul said that in this verse is an allegory, and compares the barren woman with Jerusalem above, and the Jews at natural Jerusalem with Hagar, the ones who are slaves. But there is an even more timely and fitting allegory for today. The Hagar today is Christianity, the sons of the bondwoman, as Paul called them in Galatians 4:30-31, a premature Ishmael. Christianity has never been born from above. Show us one Christian who is in an incorruptible born-from-above body. But instead, they are all dead, in the grave, sleeping! Jerusalem above remains barren until a people can ascend alive and be born from above.

Who then are these who will receive this promise? We know from 1 Samuel 2:5 and its fulfillment that it will be those who are a part of the thirteen, the one-and-twelve government. These are the eighth that redeems the seven, the Elijah Bride. These are the ones who receive the promise of the first resurrection spoken of here, and the sons of the desolate/barren will become more numerous than the sons of the married woman. She who has many children (Christianity) will now languish, diminish, and fade away.

Thus we see the testimony here:

“Those who were full hire themselves out for bread (Christians),
But those who were hungry cease to hunger (the Bride).

Even the barren give birth to seven (the redeemed Bride),
But she who has many children languishes (Christians)”

Once again I am grateful to Yahweh for using “the lad,” David Shepherd, to provide the unleavened barley bread, used here as broken and multiplied.

NOAH – THE BRIDE

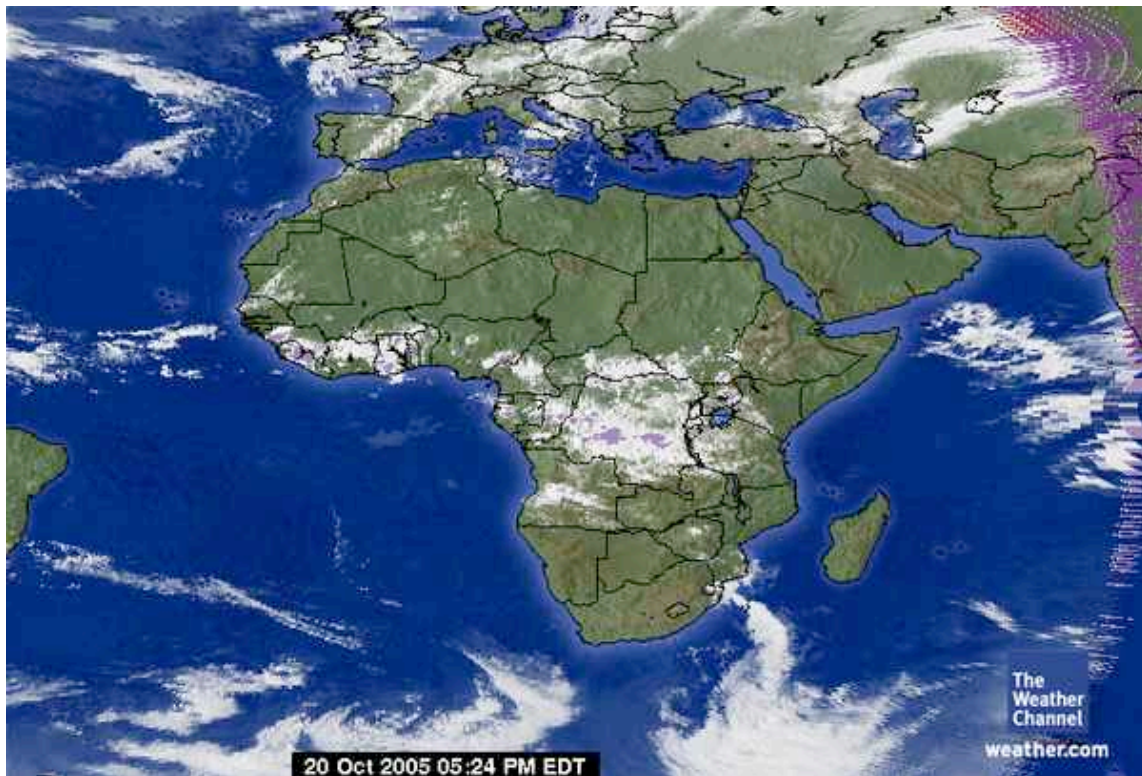
In 2 Peter 2:5 we read that Yahweh “preserved Noah, **the eighth**, a preacher of righteousness, bringing a flood upon the world of the ungodly.” And what was the prophecy regarding this eighth man, Noah? In Genesis 5:29 we read – “This one will give us rest from our work and from the toil of our hands arising from the ground which Yahweh has cursed.” Very importantly, did Noah indeed fulfill this prophecy and deliver man from the curse from the ground and give rest? Absolutely not! All that Noah brought was death! So to what does this prophecy look, and when and how is it to be fulfilled? Very simple – **it is fulfilled by adding “the eighth,” the government of Noah, which we the Bride have now done, and as a work even fulfill.**

Nearly 5,000 years later, the Bride is the fulfillment of the promise concerning Noah – that he would give us rest from the curse. This law regarding Noah, the law of adding “the eighth,” is precisely the government that was applied at Trumpets. Furthermore, the Bride is the eighth work that redeems the mark-of-the-beast-seven work of Christianity. Thus, **the Bride is the long awaited and promised fulfillment of Noah.**

In Revelation 12:15 we read – “And the serpent poured water like a river out of his mouth after the woman, so that he might cause her to be swept away with the flood.” On October 16-17 the Bride met in this man’s home to perform the critical intercessions of adding the eighth and to establish the twelve apostles. On October 18 Bride members continued to fellowship together, Bob was established to replace Russ, and we went to Montauk so Kyle could immerse himself in a spring. On October 19 the final work per this four-day period of time was completed when Carroll and I drove to the home of Russ and told him of the required change. On the way home, with a sense of fulfillment, we experienced a great rain!

The next morning, Kyle called and directed me to the following amazing October 20 satellite photos of Africa.

What do you see? On the day following the completion of this critical intercession and fulfillment, do we not see testified here Satan spewing something out of his mouth? What could it be? And what could it mean? This is an unmistakably graphic representation of Satan, and the

only thing that he is recorded as spewing out of his mouth is water in Revelation 12:15, which is what the cloud here certainly is.

In this section we are going to begin to address the matter of Yahweh's mercy. When someone looks at this picture and thinks about what is written in Revelation 12:15, they might respond in the realm of most Christians and think that this is a bad testimony for today. But quite the contrary, it is not! In fact, it is and was most encouraging!

We know that for 2,000 years, Satan has spewed out wrath and death, even as the flood on the earth was wrath and death. But that time has come to an end. Satan only had a right to two millennium via the 2,000 swine. Furthermore, Noah's flood came at the end of a 120 year probation period (Genesis 6:3). Now, it is time for another flood. The year 1993 marked the end of 120 Jubilees from Adam, and it is time for the promised flood of Yahweh's Spirit that covers the earth.

This is in fact what is prophesied in these pictures of Satan/Africa. Indeed, Satan has been used for destruction; but that which has been used for evil, will now be turned for good. If Satan poured out water for destruction, then by his actions he sets forth the inevitability that water will be poured out for good. Thus, that which we see testified in these satellite photos on October 20, is actually a testimony of the good that is now due. This is the way of Yahweh. **What Satan has done for evil, determines what Yahweh will do for good. In the same measure evil is poured out, so will good be poured out. This is a way of Yahweh. He precedes, and even foreshadows, good, with that which is evil.**

For example, Yahshua came early, before the time, and gave the kingdom to man. As a result of this premature Saul work, the kingdom of heaven was totally corrupted and there was no fruit on the fig tree. It was not the season for figs (Christianity Mark 11:13-14). The net result of this early establishment of the kingdom before the time was in fact a curse! But, once again, that which is first used as a curse, becomes the way for the blessing.

If Yahweh gave the church the full 3,000 years that were promised them, it would be – “My God, my God, why have You forsaken us?” But in fulfillment of that which was first used for evil, Yahweh now does the same for good – He once again comes early and reverses the curse! **Because He gave the kingdom of heaven to man early, resulting in corruption and death, He can now come early once again, stacking the eighth Millennium on the seventh, and do exceptionally good for man.** This is the way of Yahweh – He first sends corruption, and then uses it to bring deliverance and life!

Likewise, on Mount Sinai during Pentecost, 3,000 were slain with the sword (Exodus 32:28); therefore, on Pentecost at the former rain, 3,000 came into the kingdom (Acts 2:41). That which meant destruction and death for the former, meant life and fulfillment for the latter. Therefore, if Satan was given the right to spew out water from his mouth for destruction, then in a positive way the latter rain can and will come forth so as to cover the earth for good. Evil is turned to good. This is the hope we see in these satellite photos on October 20, the day after the immensely important four days of intercession and fulfillment when Yahweh breathed on us. So what then is our promise? That it is time for the latter rain be poured out upon the earth.

The first flood had the promise of being used for good in bringing men into rest; but it was in fact used to effect death, and failed to bring men into that rest. But it is this very thing, even by its failure, that promises the latter fulfillment. The former is the first bird of Leviticus 14:1-7 that is slain over an earthen vessel. But in truth, it is because of that first loss that the second bird can receive the good of being released alive. The first flood is the first bird that produces death; but also, because of this wrath and death price that was paid, it purchases or sets forth the rights for the true fulfillment – life and the promised rest from the curse that is on the earth. Once again, this is the rest prophesied by adding the eighth – the redeeming Bride.

The dating and fulfillment of this redeeming flood is set forth in the words of Yahshua, when He said in first Remnant Matthew 24:37-39:

"For the coming of the Son of Man will be just like the days of Noah. For as in those days before the flood they were eating and drinking, marrying and giving in marriage, until the day that Noah entered the ark, and they did not understand until the flood came and took them all away; so will the coming of the Son of Man be."

And in second Remnant Luke 17:26-27:

"And just as it happened in the days of Noah, so it will be also in the days of the Son of Man: they were eating, they were drinking, they were marrying, they were being given in marriage, until the day that Noah entered the ark, and the flood came and destroyed them all."

That which we are learning here adds an entirely new emphasis and even meaning to these statements. The flood that is to be the fulfillment of that foreshadowed by Noah, is dated to be at the time of Yahshau's return, and indeed will carry away alive "the eighth." Even as Noah and those with him ascended alive, so the second Remnant will ascend alive via the latter rain flood of Yahweh's Spirit that is the good fulfillment of the negative type, signaling Yahshua's return.

In our 2002 intercession wherein we walked out the nine trips up Mount Sinai, Yahweh performed a very encouraging and confirming testimony for today. Not only does it speak regarding Yahweh's truth concerning this matter of the eighth, but it is also encouraging that He has been leading and teaching and using us in these last few years. On our eighth day when we went to watch Grace, my youngest daughter, perform in a concert, Yahweh gave us the incredible experience in which we literally drove through two rainbows! You can read about this in the [2002 Passover Report](#). Clearly, Yahweh was attesting by these incredible rainbows on the eighth day the association of "the eighth" per Noah and the Bride, and the promised fulfillment of the latter rain flood. And once again, these truths that we are learning today were being revealed in type in 2002.

Yahweh is now going to reverse the curse, and what has beforehand been for evil, He will now use for good. Cain killed Abel, but now He is going to use "Cains" for good. Cains used in the Bible for good were Jael, Zipporah (Moses' wife), and the Rechabites. This choice of "Cains" was even prophesied just recently when in Virginia (the virgin), Democrat gubernatorial candidate, Kaine (which is actually a very accurate spelling of Cain, evidenced by the equal

translation Kain and Kenites), won in his race against, of all names, Kilgore (or killing Satan). Yahweh is going to have mercy, even on Satan.

Yahweh is now going to reverse the curse and use evil for good. The office of Judas has been used for evil for 2,000 years, but Yahweh will now use that office for good.

Yahweh is now going to reverse the curse and use evil for good. Since the garden of Eden, the woman has been used as a curse on man, including the Curse of 1920. Since the time of Noah, the black man has been used as a curse on man, including the Curse of 1920. Since the Curse of 1920, the medical community has been used as a curse to destroy multiplied millions of innocent and vulnerable lives. Since the beginning of the church, pastors have been used as a curse on the church, teaching false doctrines and failing to deliver the people. But now Yahweh has placed these specific ones in the office as apostles and will use them for good to reverse these very curses. **The very ones who caused the curses, will now be the ones who will reverse them and bring His abundant blessings! Yahweh is having mercy.**

Yahweh is now going to reverse the curse and use evil for good. For 2,000 years the church (Christianity) has been used to defile and destroy the kingdom of heaven here on earth, leading all men to death. But now He will use the church (the Bride) to restore and deliver the kingdom of heaven and to deliver men from death.

But even more so, the fact is that it was the first Remnant who caused the curse on the church, and it will now be the second Remnant who will reverse the curse. Even as Eve ate from the tree of the knowledge of good and evil and gave the forbidden fruit to Adam, so the first Remnant were the first to bring the curse on the church, evidenced by the eleven establishing the seven. They then gave the forbidden fruit to the body of Christ, and they too have been cursed. But in like manner as we have been seeing, Yahweh will equally use the very cause of the curse, the Remnant, to reverse it! Hallelu-yah!

Yahweh is now going to reverse the curse and use evil for good. This is our hope and our much needed promise. Even as it is written in Hosea 6:1-3, so it is for us today as we have now entered into the promised "third day," the Millennial reign:

"Come, let us return to Yahweh,
For He has torn us, but He will heal us;
He has wounded us, but He will bandage us.
He will revive us after two days;
He will raise us up on the third day,
That we may live before Him.
So let us know, let us press on to know Yahweh.
His going forth is as certain as the dawn;
And He will come to us like the rain,
Like the spring rain watering the earth."

That which Yahweh has performed in wrath for 2,000 years, He will now perform for good and healing, evidenced by what He is showing His Bride today, giving us eyes to see things that no man has ever seen, and providing the legal understanding and fulfillment that is entirely critical

for our deliverance. Now is the time for the promised latter rain that will water the earth following nearly 2,000 years of drought. In order to bring this rain, the promised “Noah” must be fulfilled. “Noah” means “rest,” the very promise of Hebrews 3:14-4:6 per the Tabernacles entrance into the promised land, the first resurrection.

It is noteworthy that Noah’s name does not even appear in Christianity Mark, for Christianity could not bring rest, the Sabbath Millennial rest. Yahweh is now adding the all-important eighth – the Bride, who is leading the way into the Millennial reign, Yahweh’s Sabbath rest!

REDEEMING JUDAS

On the evening of October 16, as Russ and I lay in our beds considering what Yahweh might be doing, I made the comment to him – “This accident with Ruhamah is very significant, Russ, very significant!” He concurred, and we went to sleep.

It was obvious that Yahweh was indeed having mercy, the meaning of “Ruhamah,” evidenced not only by the accident but by the establishment to the twelve apostles to include two women, two black men, two pastors, and even the doctor and the one who sought their trade. But as you will now see, that which took place in the days following attested to this message of mercy as well, further confirming Yahweh’s governmental order evidenced in the first twelve apostles.

You will recall that the general pattern of the twelve apostles was eleven plus the office that would endure to the end – the twelfth apostle. Of course this office was first given to Judas. But the fact was, Yahshua had already clearly stated to whom that office truly belonged, and that was to Satan, the devil – “Did I Myself not choose you, the twelve, and one of you is the devil” (John 6:70). For at least three clear reasons, it was critical that Satan have that office:

- (1.) Even as Judas had baptized Christ into death as the Elijah, so Satan had to baptize the body of Christ into death, which he has done for 2,000 years.
- (2.) In order for the wealth of the sinner to be given to the righteous (Proverb 13:22), the office of Judas, who had the moneybox, had to be given to Satan, so that when that office was given back to a man, that man would legally receive the wealth that Satan and the sinner have possessed.
- (3.) By giving that office to Satan, he has kept it viable to this day. No mortal man could have done this, so Yahweh gave it to an immortal being. Yahweh has now given that office back to a man, thereby repairing the breach of the last 2,000 years.

You have already seen that per the latter twelve apostles, that office was taken from Russ, who stepped into the place of a Judas by leaving early. It was abundantly clear that the office had to be taken away from him and given to Bob, the other pastor, and this was indeed done. But what we did not expect was that the pattern was not yet finished!

Russ was the Judas, and the office then went to the next pastor, Bob. Bob is an Assembly of God pastor in California. After Bob's acceptance of this office, I contacted him about the Bride uniting together with him and his people there at his facility for the Tabernacles Pentecost. I was surprised with his reply. Without going into this, he felt that it was premature and that we needed instead to focus on the family. Bob failed to see the tremendous legal importance of this gathering, and its urgency. When I replied back to him, his response to me was that I not contact him any more.

Now, one could look at this and get all involved in the emotions of it, or one could look at it in the light of prophecy and government. The fact was, Yahweh was attesting in that specific office precisely what has happened to the same office among the first twelve apostles. While Russ had stepped into the place of Judas, Bob had stepped into the place of Satan, the devil!

We already looked at the testimony that Russ' name evidenced; let us also consider Bob's, as well as some other interesting and quite revealing testimonies. "Robert" means "of shining fame." In Ezekiel 28:12-15 we see Satan described in all of his splendor and beauty – "You had the seal of perfection, full of wisdom and perfect in beauty." While Bob's name in itself is not bad, it does indicate the obvious fame Satan has had – all the "kingdoms of the world and their glory" were given to him (Matthew 4:8-9). Obviously Bob did not have this kind of wealth and glory and fame; but his name does prophecy of it.

Do not misunderstand, I am not demonizing Bob; but in his intercessorial role as Satan, he does legally fit. For example, most striking, while Satan has been taking men to the grave for 2,000 years, Bob is not just a pastor, he is a licensed funeral director. As such, he has the legal authority to declare people dead, to prepare them for burial, and to bury them, and this is what he does. Bob is a full time funeral director. Like Satan, he legally and literally puts people in the grave (Hebrews 2:14, lit., "has the power of death"). In type, he is clearly comparable to Satan in this regard.

Additionally, of these three Assembly of God pastors – Carroll, Russ, and Bob – Bob is the only one who is still in the system of Christianity. He is still an ordained AG minister in an AG building meeting on Sundays, Christianity's sabbath. In other words, he is legally a part of mystery Babylon. Furthermore, and I was quite aware of this from the outset, California is clearly prophetic of the 2,000 year period of Christianity, with Oregon prophetic of the third part of the church that passes through the fire. Thus, not only was Bob prophetic of Satan in his legal ties with Christianity, prophetically he was in the 2,000 year period of the church that belongs to Satan, which he buries.

But you say that Bob believed in Remnant truth and was given some marvelous insight. That is true; but don't forget that Satan was once "full of wisdom," and he fell! So did Bob. Thus we see numerous testimonies that Bob was an intercessorial Satan, including giving into feminine misplaced mercy that leads astray and causes one to fall short.

When Bob failed, I turned to Yahweh for what He wanted. I saw clearly that He was completing the testimony of this office to its fullest, and this meant that it would now go to another man, the

fulfillment in type of the present-day twelfth apostle. But who would it be? I waited on Yahweh to show me.

Because of the pattern of two women, two black men, and two pastors, it seemed evident that the intercessional testimony of the two pastors had to remain. But who would it be? It had to be a pastor, even a former pastor.

The only ones I knew who might fill that role were either Russ or a friend of mine whom Yahweh had already used as a type of the Remnant. Carroll asked me about Russ, but I could not install any man in that office without knowing from Yahweh who it was to be.

Seeking to walk circumspectly, I began calling my friend; but he would not return my calls. It was as though he was dead, for he would not reply to me, no matter how many times I called. Then one evening Kyle called me and appealed to me that I restore Russ, believing that it was a testimony of continuing mercy. I told Kyle the same thing I had told Carroll – I could not do so unless I understood clearly from Yahweh that this was governmentally correct. I do not have the right to do anything of my own will, but only the will of the Father, and He had not shown me what to do.

Of course Kyle has often been an Elijah to me by the will of Yahweh, and the next morning as I awoke, the truth that had been addressed in the writing, [*Until Shiloh Comes*](#), came to me. Here we read:

This brings to a conclusion the recorded course of the ark of the covenant and His presence. Once Jerusalem was destroyed, even though a temple was rebuilt, there was never the ark or His presence as it was in Shiloh and in Solomon's temple. All that remained was the promise in Haggai 2:9 that the glory of a latter house would be greater than the former, which was obviously not fulfilled in Zerubbabel's temple. Yahweh placed His presence in Shiloh. He then moved His presence to Jerusalem. But then after making good His warning, He removed His presence and the ark altogether. It seems that the story of His presence falls ominously quiet at this point. If He removed it from Shiloh and placed it in Jerusalem, then where is the promise of His presence after removing it from Jerusalem?

Before answering this, let us recall the highly impacting principle and way of Yahweh called the passing over principle. In [*The Passing Over Principle*](#), we conclusively see that Yahweh passes over the first, He passes over the second, and He takes the third. This is precisely what we see here regarding Yahweh's presence. He passed over Shiloh/Ephraim, He passed over Jerusalem/Judah, and He will take the third. So what is the third place He will take?

This was the precise question I was having to ask. He passed over Russ/Judas, He passed over Bob/Satan, so who would be the third person He would take? We continue:

The answer to this question is as silent and elusive as what we read in Hebrews 7:14 concerning a priesthood out of Judah, regarding which Moses spoke nothing. Suddenly

Yahweh did something that no one expected and was not clearly announced beforehand! It would seem that the conclusion of this issue of the presence of Yahweh ends here with His rejection of Judah, were it not for Genesis 49:10 regarding the rod that Judah possessed. So, what happens to the promise of His presence? He abandoned Shiloh/Ephraim and went to Jerusalem/Judah. So where does He go after abandoning Jerusalem/Judah? The answer is plainly stated. **He returns to Shiloh!**

“The rod shall not depart from Judah,
Nor the decree from between his feet,
Until Shiloh comes....”

That was the governmental answer I had to have! I had to see the before-followed pattern of that which Yahweh does before I could do anything. When I called Kyle that day to talk with him about this, I realized another VERY obvious pattern as well. Of course! He first called the first Remnant and then passed over them and took Christianity; but even as He rejected and passed over Jerusalem, He has now passed over Christianity and gone back to the Remnant, this time to the second Remnant! The consistent pattern was thus clear and obvious. Yahweh was attesting to having mercy, and His design was to go back to the one who had failed – the Judas, Russ.

When I saw this, the testimony of my other pastor friend became abundantly clear. My friend, whom I wondered if he would be the replacement for Russ, was dead to me. He would never reply to me. In Matthew 26:50 Judas is called “friend” by Yahshua, and Yahweh used the situation per my friend to testify of Judas, Yahshua’s friend.

In these last days when it was time for Yahweh to take the office from Satan and give it to a man, to whom should that office have gone? It should have gone back to Judas, Yahshua’s friend. Judas did repent and threw the money into the temple. But there was only one problem. Even as Yahweh used my pastor friend to be dead to me and I could not offer that office to him, so Judas was dead and that office could not be restored to him. Thus, this man had to be the replacement of Judas – a man in his stead.

But that was not the case with Russ; he was still alive during this transfer and could receive the office. And, as you will now see, another paid the price so that he could receive this office as though resurrected.

In the past, Russ and Carroll ministered together in a church with a third man who was the minister of music. Later on, these three went their separate ways, and the music minister went back into the world and back into Catholicism. At the time that Carroll began reading The Remnant Bride web site, and just before we talked for the first time, the former music minister hung himself. Both Russ and Carroll, independent of each other, sensed and even concluded that what this man did was an act of Judas, who also hanged himself (Matthew 27:5).

What does this have to do with Russ? That man gave up his life so that Russ could have a second chance. Is this really true? Absolutely it is! We do not realize how much patterns are followed and what they mean with regard to man. Russ could not die as a Judas and still receive the office; so it was necessary that another die in his place, even as Yahshua did so for us. Russ’

and Carroll's third-part associate fulfilled the law of Yahweh and paid the price of death so that Russ could be restored to his office. This is nothing less than the two birds testimony of Leviticus 14:1-7 wherein one gives up his life for another. This happens all the time, for no death is without purpose, but is effectual for life in another. People pay the price for others, both knowingly and unknowingly.

To let you know further how this type of sacrifice can work, let us consider another testimony before returning to this matter regarding Russ. In 2003 when I lost my family and the Remnant Bride died, I had nothing to live for and made plans that I knew would lead me to the very place where I had served in years past – to the homeless. I knew my fate; I no longer cared about life and told my daughter that I would end up in a homeless shelter. The only hope I had was that He would keep me from going the way I planned, and He did. Instead, I ended up in New York with my dear friend and brother, Peter Douglas, doing an extensive make-ready on a home to get it ready to sale. Afterwards, I went back to our home in Washington state and fought the court action by my wife (a legal separation), getting it overturned and eventually totally dismissed. I survived what should have totally destroyed me, and never went to the homeless shelter. But, another man did!

A couple of years before this, we paid the way for a man to fly in to visit with Kyle and me. He had his own web site and had even taught about a remnant bride. While there, the three of us, with our children, went to a river where I sat on a large rock while they got in the water. They encouraged me to get in the water, but I told them that my job was to sit on the rock (referring to Rizpah in 2 Samuel 21:10).

A few days later, we were on a mountain sledding, and I encouraged that man to sled with us. He was sitting to the side on a rock just watching. Instead of joining us, he rebuked me and said that it was his turn to sit on the rock! I never forgot that, because the intercession of sitting on a rock means taking on great sorrows, evidenced by Rizpah. And even as it came out of his mouth; yes indeed, he would sit on that rock, for me!

After getting back to Washington and seeing my life begin to get back in order, especially after the court action was overturned and the very important 2004 Passover, I found out that that man had subsequently lost his family as well, and of all places ended up in a homeless shelter, and to my knowledge is there even as this is being written. Yahweh used that man to sit on a rock for me, taking my destiny, and paying the price for me so that I did not have to pay it. Out of his own mouth he set forth what would happen, and it meant my deliverance, for which I am very grateful. If he had not done so, you would not be reading this today.

This was the same thing with Russ. Yahweh used the music minister's sacrifice to pay the price for the man who would stand in the place of Satan as the last-days twelfth apostle. Thus Yahweh completed His testimony of that incredibly significant office. He first gave it to Russ; then because of his act as a Judas gave it to Bob, who stood in the place of Satan; and then in His mercy and according to His ways and a price paid by another, gave that office back to Russ.

Another thing that should be addressed, as mentioned earlier, was Russ' attitude in this. On November 2, Eric and I drove over to Russ' home for me to talk with him about this. I told Russ

the government of it, how it all unfolded, and asked him to step back into that office. He accepted with the same resolve to do the will of the Father as he had when I took the office from him. This too was an affirmation that Russ was to return to that office.

When still not knowing who was to fill that place, one thing that encouraged me was the experience where Yahweh had revealed to me the [twelve areas of the soul](#). He allowed my spirit to reveal eleven of them, but personally spoke to me the twelfth. This encouraged me, for I knew that this one office would be unique from the rest, which it certainly was proving to be.

What was the twelfth area of the soul that Yahweh spoke to me? It was **attitude!** And if anyone had evidenced the right attitude in a potentially troubling situation, it was Russ. His attitude was only to do the will of the Father, whether it meant loss, or whether it meant gain. He was willing to lay the office down, and was equally willing to receive it again, both with the same sense of acceptance. Russ represented in a positive and fulfilling way the twelfth area of the soul – attitude!

And quite interestingly, on October 19 Russ lost the office of the twelfth apostle. Then precisely two weeks later on November 2 it was restored to him. In type and pattern, this was the same amount of time between Judas and myself – 2,000 years. That office was removed from Russ for a prophetic 2,000 years – two weeks.

In conclusion, once again we see testified that that which was once used for destruction, will now be used for restoration. Yahweh was attesting the very thing He prophetically represented when in January, 1982, He told Russ to name his child Ruhamah – Yahweh would have mercy. And He has evidenced once again the mercy He is having now by restoring Russ as the twelfth apostle. Blessed be Yahweh for His mercy!

It is now my honor and great delight to present to you the last-days twelve apostles. They are listed by age, from the oldest to the youngest, starting with a father and ending with his daughter. These are the names written on the stones in Revelation 21:14.

And might it be noted, in the writing, [Return of the Raven, page 2](#), posted on July 17, 2005, a month-and-a-half before this man left for Salem, the following was stated – “Today, as I see the significance of the raven being sent out, I take hope that this journey wherein I am equally going out and trusting totally in Him, will find the same wonderful results. And in this regard, I equally take great hope that the raven will rejoice and dance a jig!”

On August 29 I pulled out of Washington with the clear awareness and hope that I was beginning my raven work. My raven, Louie, was sent out to identify my bride. Now, a mere one and a half months after I was a raven sent out, Yahweh used this man to identify the Bride, even my Bride; and here they are!

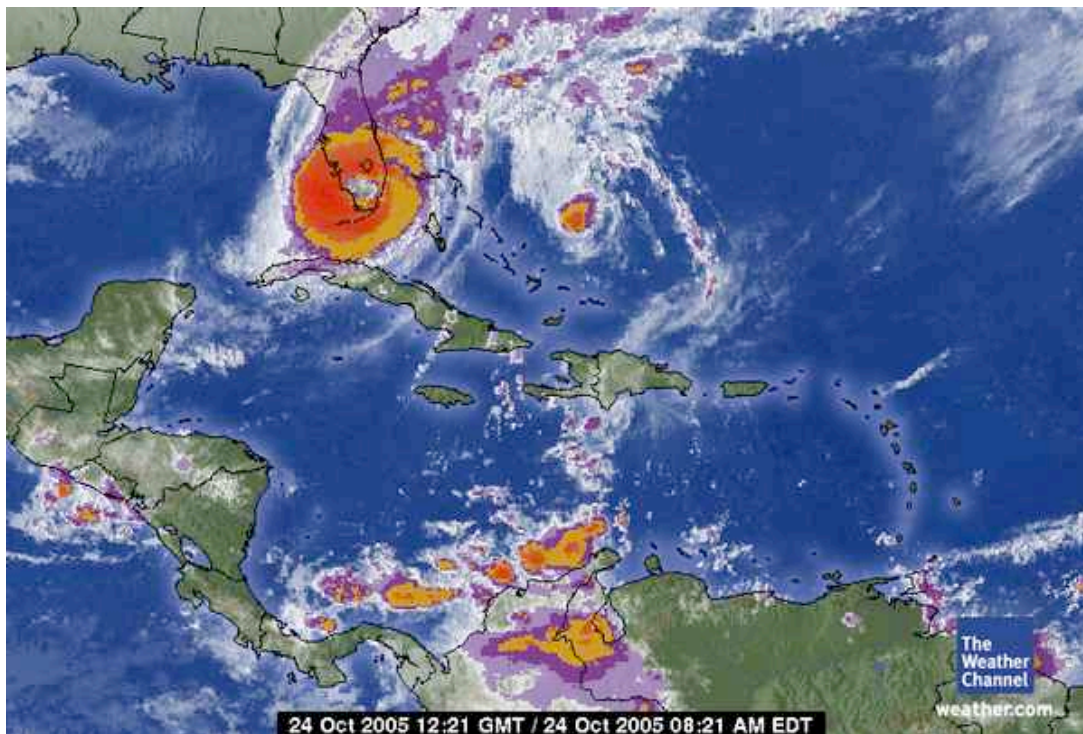

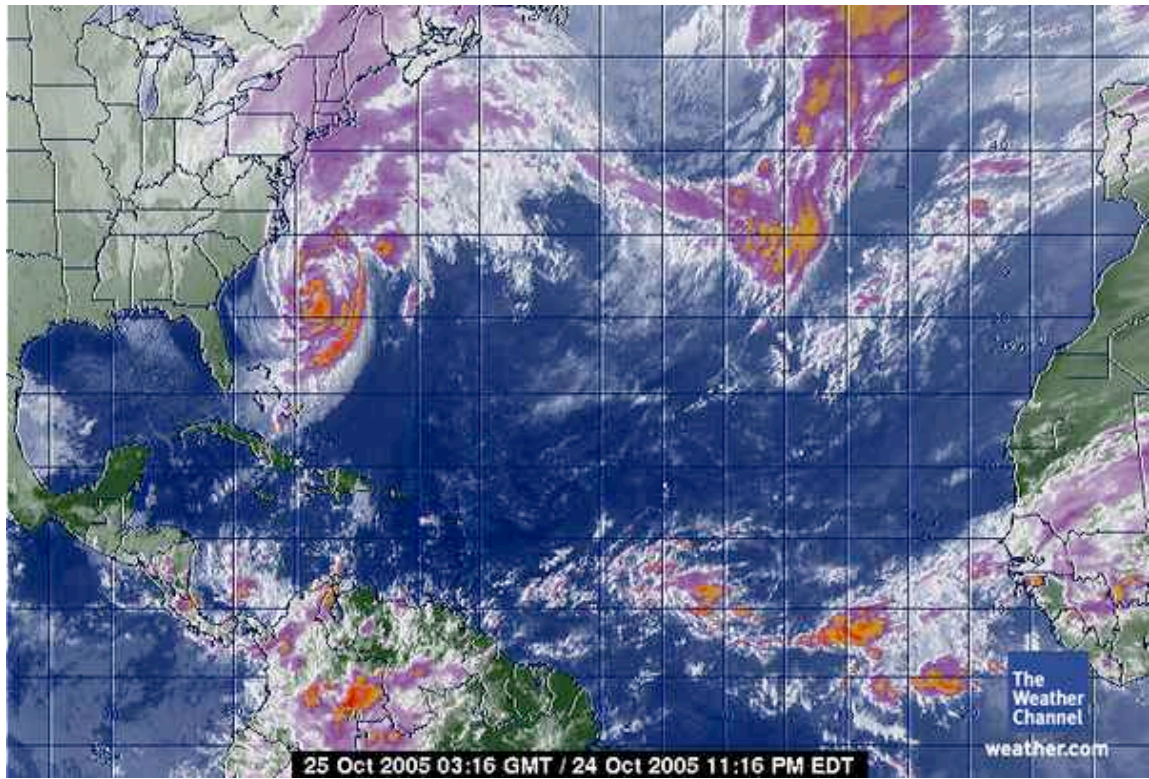
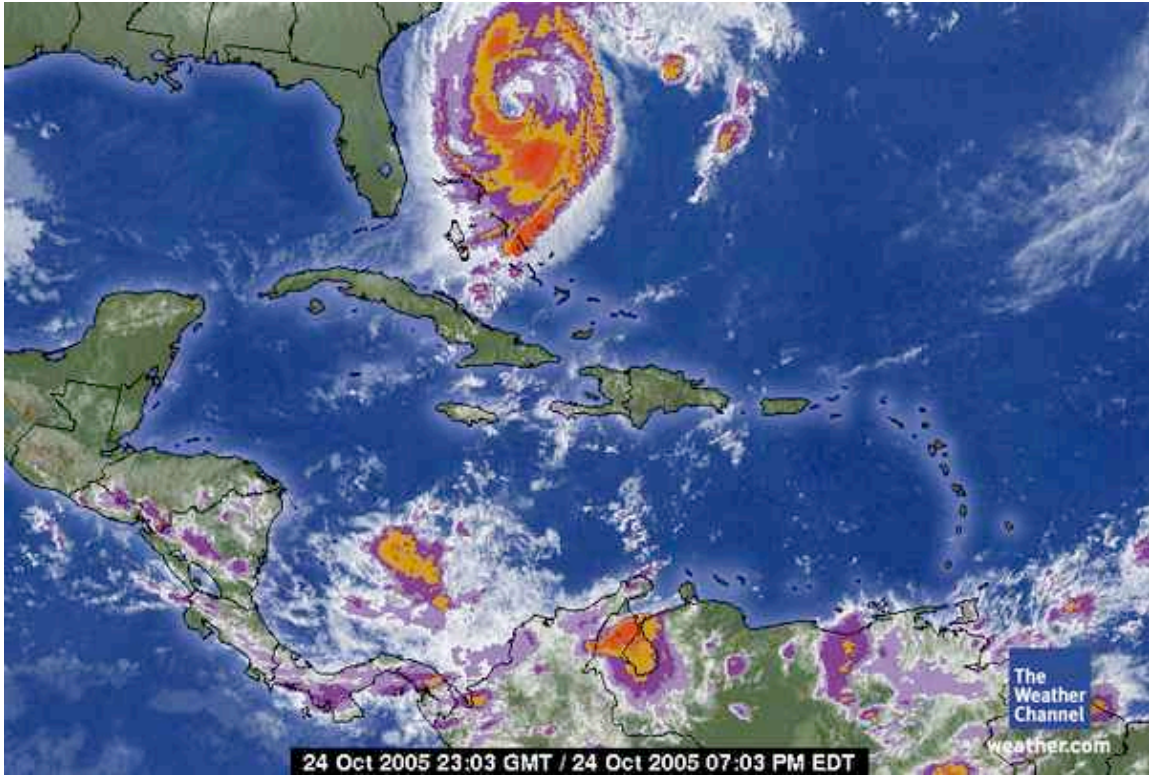

GOVERNMENT IS RELATIONAL

In section 2 of this writing, we noted in Hosea 1:11 that the union of Judah and Israel under “one leader” produces the testimony that “they will go up/ascend from the land, for great will be the day of Jezreel,” and that Lo-ammi and Lo-ruhamah (“not My people” and “not have mercy”) are then called Ammi and Ruhamah (“My people” and “mercy”). Thus we see the testimony of Yahweh having mercy.

On October 18 Wilma became a hurricane and on the 21st hit the Yucatan Peninsula. Then on October 24 it made landfall on Florida and took the rod. On October 22 the first ever Tropical Storm Alpha formed. Alpha crossed Haiti and then went northward, and on October 24 these two storms united as one. Following are satellite photos of their union. In the first image you can see the two distinct storms – Wilma over Florida and Alpha east of it. In the next image you see the two merging closer together. And finally in the third broader image the two unite as one.





Even as Yahweh has been attesting to having mercy in the order of Ruhamah, He was once again evidencing this with the union of Wilma and first-ever Alpha. From the greater sense, this is a

union of Christianity and the Remnant; for once again as a testimony of Christianity, Wilma took the rod. And as a representation of the Remnant, first-ever Alpha was a new thing. When one considers Zechariah 4 and the places the two Remnant have on each side of the lampstand, indeed they are truly the alpha and the omega of the church, the beginning and the end. As testified by these two hurricanes, the greater work that was from the west, or death, Christianity; is united with the much lesser work from the east, or life, the Remnant. The testimony then was the union of these two kingdom works that brings mercy!

But before there is this union of these two greater works, there must first be the union of the two Remnant – the first and the second, the alpha and the omega. This union will not fully come until the second Remnant is completed and the two are joined together in heaven (on the mountain) to receive their glorified incorruptible bodies. Until then, we today experience this union that evokes mercy by the formation and union of the twelve apostles and the twelfth apostle, who is legally a part of the first Remnant. Legally, the two are united under “one leader.” Thus we see that these two whirlwinds attest to this union and Yahweh’s mercy in this very day – Ammi and Ruhamah!

Having noted once again this mercy, let us consider the question of Yahweh adding two women to the last-days twelve apostles, clearly a testimony of mercy. Revelation 4:4 indicates that the twenty-four elders will have some form of governing in their responsibilities, for they sit on twenty-four thrones around Yahshua, who equally sits on a throne. Also, in Matthew 19:28 we read that the original twelve apostles were told that they would “sit upon twelve thrones, judging the twelve tribes of Israel.”

So how is it that two women could perform such critical judgment? Very simply, when Linda and Kim, or whatever their new names might be, sit on their thrones, they will be neither male nor female, but will be like the angels (Matthew 22:29—30). For now, they are two women who critically represent the reverse of the Curse of 1920, or even the reverse of the curse that goes all the way back to Eve. They occupy a governmental intercessorial place, and it is yet to be seen what their roles will fully be before we enter into immortality. They may be another person just like you for now. On the other hand, they very well, and very likely, will be anointed as one of the twelve that are sent out, even as the original twelve were sent out (Luke 9:1-6) and as promised in kingdom John 15:16:

“You did not choose Me but I chose you, and appointed you that you should go and bear fruit, and that your fruit should remain; that whatever you ask of the Father in My Name He may give to you.”

How this work will unfold is to be seen, but let us consider the following regarding this matter of adding two women. In the writing, [Two Trees In The Garden, page 4](#), we see that there are ten dimensions of God. The first three are the three dimensions of space – height, width, and depth. The fourth dimension is time. The fifth dimension is the tree of the knowledge of good and evil, or Christianity. The sixth dimension is the tree of life, the Remnant. The seventh dimension is restored Christianity. And the remaining eighth, ninth, and tenth dimensions are the nations and the angels.

It is most significant that each higher dimension has an ability to effect things that the lower dimensions lack. For example, the law of gravity is a certain and prevailing law; however, the law of aerodynamics is a greater law, allowing objects to overcome and exceed the law of gravity. In like manner, the law of time has an ability to change the first three dimensions. For example, a tree on any given day is fixed at specific dimensions of height, width, and depth. However, the fourth dimension of time has the ability to change those dimensions, as well as the tree's seasonal appearance. Thus, the fourth dimension of time is a greater dimension.

This is true with the fifth dimension of Christianity as well. Take for example one's emotional or even physical state. One may be destined for certain demise, either emotionally or physically, via the four lesser dimensions; but by the higher fifth dimension of Christianity one can be redeemed in those emotions or divinely physically healed. Thus the fifth dimension affords things that are lacking in the lower four dimensions.

But even as there are limitations in the lesser four dimensions, so there are limitations in all of these first five dimensions. The truth of this is evidenced in Yahshua's parable regarding the ten virgins in Matthew 25:1-13. One can be certain that when Yahshua told this parable, there was specific governmental order intended when the number of virgins was the same as the number of the dimensions of Yahweh – ten.

In this governmental account, the ten virgins were divided five and five. The first five were unique in that they lacked sufficient oil, not taking with them flasks of oil; but the latter five took sufficient oil with them so as to make the journey. In the end, the first five arrived too late and were not able to enter into the wedding feast, while the other five did enter.

Here we see the weakness of the first five dimensions – they do not have a sufficient supply of the oil of the Holy Spirit in order to enter into the marriage of the Lamb, which is where we are today. There are 2,000 years of tree-of-the-knowledge-of-good-and-evil Christians who are in the grave, and by that very account cannot be in the wedding feast of the Lamb. Likewise, many Christians today will not enter into the wedding because of their own lack, and will be told to go and take their money (that they will not give up in order to be His disciple) and buy their way in, which of course has failed for 2,000 years, and will continue to fail.

Thus we see that while the first five dimensions, including Christianity, have ever-increasing authority, they have not been and are not now sufficient to bring one into the marriage of the Lamb. The first opportunity for this is afforded in the higher sixth dimension of the Remnant, the first dimension to have enough oil of the Holy Spirit. And for Christianity, they will not be able to enter into a place of effectual authority until they become the seventh dimension.

So why do we address this matter at this point? Because things are possible at higher dimensions that are not possible at lower dimensions; and entrance of the Bride company into immortality via the extra oil of the Spirit, will allow things to take place that were not possible at the lower dimensions, including two women becoming apostles and sitting on two thrones with twenty-two men (or actually twenty-three). That which was not legal in the lesser fifth dimension, will be legal in the sixth whereby the division of the gender will be removed and the two will become one.

But now for an important point – until women and men become one in gender, putting off the sexual differences of the natural, as long as we relate to one another as men and women, Yahweh has ordained that those governmental differences remain. In this regard, there is a VERY important truth concerning Yahweh's laws, and that is:

Law/government is relational.

Law is applicable relative to its setting or according to what it is relating to. In the ways of Yahweh, law does not change. It may temporarily be modified, as we see when Yahweh granted man divorce because of his "hardness of heart ...; but from the beginning it has not been that way" (Matthew 19:8, Mark 10:5, and not in Luke or John). But even then, for Yahweh to do this He has to do so legally. Even so, any law is in force as it relates to the things around it. While the following examples are not perfect, they at least give an idea of how law is relational.

If you lived in America and went to another country, even though you are an American, when you stepped onto that other country's soil, you would be subject to the laws of that country. You would thus soon find out the truth that law/government is relational, relative to your present environment. When in that country, you would have to conform to its laws. For example, in America we drive on the right side of the road; but if you visited the UK, you would have to drive on the left side of the road. If you said that you were an American and we drive on the right side of the road and proceeded to do so, you would not get very far before the reality of your new relational government would confront you, maybe even to your harm. Thus, one has to conform to government per one's relationships.

If you worked at a job, your association with that job would bring with it certain relational responsibilities and rights. One person might be able to walk into a high security area, but another could not. One person in their duty as a police officer or soldier might have a right to kill someone, but others cannot. What one can and cannot do is always a question of government or law based on relationships.

One can spank their own children, at least here in America, but they cannot spank another's child unless they have permission. One can have relations with their spouse, but by Yahweh's laws they cannot have relations with another man's spouse. Why? Because law/government is relational.

So what does this have to do with the apostles, and more specifically with the two women apostles? Until these two women enter into their immortal bodies, they are still obligated to the laws of the male-female relationships set forth by Yahweh. This is rather obvious in most regards, particularly relating to the practical, but it also applies in the spiritual. **As long as a woman is in an earthly body, she has a relational responsibility to the one from whom she came – the man.**

The error is to try to effect the heavenly order too early. This is what Christians have done, especially since 1920. They have tried to place women in that position of equality before it is time. Like all of Christianity, their actions are equally premature, before the time. Christianity is a Saul work that is too early. Their actions are like Saul who could not wait for the prophet of

Yahweh, Samuel, and went ahead and offered the burnt offering anyway for fear of losing the people (1 Samuel 13:8-14); and for this reason his kingdom, like Christianity's, would not endure. It was given to another who was made after Yahweh's own heart, David. Timing is critical!

We read in 1 Timothy 2:12 that the woman is not to teach or exercise authority over a man. Even though these two women have the office as an apostle, they continue to be in a male-female relationship and are thereby bound by that relational government. That government was set up by Yahweh in the very beginning in the garden of Eden, and remains to this day. Peter and Paul reiterated that government, even though Christians, who are lawless, have blatantly disregarded it. The very passage cited here concerning the woman not teaching, is clearly based upon this matter of the woman coming from the man.

But I do not allow a woman to teach or exercise authority over a man, but to remain quiet. For it was Adam who was first created, and then Eve (1 Timothy 2:12-13).

Insomuch that Yahweh redeems all things, this relationship will turn around in time, but only at the higher dimension where the lower limitations are not in effect. As Paul points out, while the woman came from the man, man also comes from the woman (1 Corinthians 11:12). For 6,000 years man has been under the government of the woman coming from man, and is thus to be ruled over by him. But when the Bride enters into immortality, fully entering into the higher sixth dimension, the man (the body of Christ) will come from the woman (the Bride). When that occurs, Yahweh will do a new thing and the woman will encompass the man, the Bride encompassing, or becoming the covering for, the body of Christ (Jeremiah 31:22). But this again is only possible at the higher dimension. Then when the body of Christ enters into the seventh dimension, the two will be neither male nor female and will be one.

On October 16-17 we interceded to reverse the Curse of 1920, and even for the curse per the woman going all the way back to Eve. With regard to reversing the Curse of 1920, the very cause of that curse was the woman abandoning her place and wanting to be equal (or even over) the man, violating the clear relational laws of Yahweh. Obviously, reversing that curse would bring the woman back into harmony with Yahweh's established governmental order in her relationship to the man.

It is quite significant that both of these ladies who are apostles came with a male authority in their lives – Linda with her brother, Eric; and Kim with her father, Cary. It is most likely that when the apostles are sent out, these brother-sister/father-daughter pairs will remain together, the male figure being a covering for the female. This is Yahweh's government and obviously His provision/order regarding these four apostles.

Will Linda and Kim be allowed to teach? In a formal setting, undoubtedly not; but it is clear that a woman can pray or prophesy if they cover their heads (1 Corinthians 11:5-10). While respecting Yahweh's government as it relates to the male-female relationships, we will see what the Holy Spirit does. It would certainly seem that the anointing of healing the sick or raising the dead as promised to the twelve (Matthew 10:8, Luke 9:6, John 15:16), should not be affected by the male-female government.

To understand why Yahweh has set forth this order regarding the man and the woman, one has to look at its governmental origin or basis. The difficulty we have today is that the Curse of 1920 has affected our societies so extraordinarily much, that it is hard to think governmentally and not emotionally.

Some would say that there is no difference between a man and a woman, but that is absolutely not true. Genesis 3:16 makes this very clear, not to speak of the many other like passages. Most certainly, in harmony with the ways of Yahweh, there is a governmental and even social reason that the man was created before the woman. We are not benefited, either personally or socially, by trying to outwit our Creator, but should instead seek to gain understanding of His ways and conform our lives and our person to them. In this world today, this means being willing to be different from others. The question is and has always been – Will we conform to Yahweh, or will we conform to Satan’s rebellion? Let us further consider Yahweh’s governmental ways.

The way of Yahweh is to create things in mirror images. As addressed in Section 4, the kingdom of heaven on earth is a mirror image of the kingdom of heaven in heaven. Likewise, man is a mirror image of Yahweh (*The Soul*). In each case, the image is made in weakness and bears a tendency toward being easily deceived and is thus given to failure. This is certainly true concerning the kingdom of heaven on earth and man. Therefore, when Yahweh set forth the command to the woman that “your desire shall be for your husband, and he will rule over you” (Genesis 3:16), this government applies universally. Should not our desire be for the kingdom of heaven above, and it should rule over us? And should not man’s desire be for Yahweh, and He should rule over us?

Therefore when Yahweh made the woman from the man, she too was a mirror image of him and followed the identical pattern of being weaker and easily deceived (1 Peter 3:7, 1 Timothy 2:14). Some people may not like to hear this or want to accept it, but it is consistent established governmental order, an order whereby the Curse of 1920 capitalized on this very weakness.

And in like regard, and this hopefully will help one to understand this matter of the man and the woman, governmentally, our soul occupies the same feminine position, while our spirit occupies the masculine position. We as individuals, whether male or female, are challenged with the same conflict that rages in society today – whether to follow the lead of our feminine soul, or to follow the lead of our masculine spirit.

In like manner, there are two Adams, one the weaker and one the redemptive – “The first man, Adam, became a living soul (the feminine); the last Adam became a life-giving spirit (the masculine)” (1 Corinthians 15:45).

Thus we see here five levels of the identical truth/pattern:

- The kingdom of heaven above in contrast to the kingdom of heaven on earth,
- Yahweh in contrast to man,
- The man in contrast to the woman,

- The spirit in contrast to the soul, and
- The last Adam is in contrast to the first Adam.

As you can see, this is all the same government. Thus, one cannot say they agree with heaven ruling, Yahweh ruling, our spirit ruling, or the last Adam ruling, and then say that the woman is governmentally equal to the man. It just does not work that way, and to pursue such would only demonstrate that the feminine soul is ruling rather than masculine government.

Given this order, the Bride then faces a very real problem, frankly equal to the problem Tamar had when Judah refused to give her to Shelah (Genesis 38). Something unique and new has to take place.

One would conclude that since the Bride comes out of the body, that the Bride will equally be a weaker and easily deceived work. Yahweh forbid, when the body is so deceived already! This would certainly be true, except for two provisions – (1) the office of Yahshua that is occupied by the twelfth apostle, and (2) the fulfillment of the sun-clothed woman. A Bride coming out of the body of Christ would be even weaker than the body if Yahweh did not provide the office of the Son of God to direct and instruct the Bride. Also, the Bride will be clothed with the Spirit, who convicts of sin (John 16:8) and guides into all truth (John 16:13). (It is worthy to note here that the Greek words for “true/truth” [#’s 225, 227, & 228] are used once in Matthew, twice in Mark, five times in Luke, and forty-eight times in Millennial kingdom John.) With these two critical provisions, the Bride will become the redeemed and much needed “[obedient people](#).”

Furthermore, Yahweh gives the Bride a legal covering that allows her to come out from the body, even as He did with the body of Christ per the Jews (as you will now see), and will establish her in the higher sixth dimension. Even as the sons of Abraham increased in understanding beyond mankind, and the body of Christ increased in understanding beyond the Jews, so the Bride is greatly increasing in understanding beyond the body. You will understand this order better as this section unfolds. Let us carefully examine this governmental truth regarding the woman/the Bride and her covering.

When the Spirit came upon this man in June, 1994, and revealed the truth of the two-part Remnant that comes out of the body of Christ, Yahweh had preceded this critical revelation with some vital and encompassing truth – the law of coverings/atonement. **Thus, very significantly, the foundation to the revelation of the Bride truth in 1994 was the writing, [Coverings](#). In fact, the writing Eric read and made commitments regarding that immediately preceded Yahweh’s revelation of the Millennial calendar, was equally *Coverings*!**

If all of this we see happening today per the Bride was initiated with these marvelous truths regarding coverings, we cannot abandon these truths without becoming misguided and adversely affecting what we do. If we violate the very cause for our understanding and its foundational truths, then we negate our cause and purpose today. This entire matter regarding the Bride is founded and being fulfilled because of the laws of coverings; and you will now see that for 6,000 years Yahweh and man have operated according to these laws of coverings. And the very reason the Bride will hold all things in common is founded on the truth of the woman covering her head. Let us review this, and even add some additional amazing and confirming truth.

In 1 Corinthians 11:3, the passage that addresses this matter regarding the woman covering her head, we read the following clear governmental order:

But I want you to understand that Christ is the head of every man, and the man is the head of the woman, and God is the head of Christ.

Thus we see this unmistakably clear governmental order.

Yahweh

Yahshua

The man

The woman

Paul then went on to explain that if the woman prays or prophesies, in other words if she either speaks to Yahweh (prayer) or on behalf of Yahweh (prophecy), then she is to cover her head. Why is this true? Because of the law of coverings. (And as thoroughly addressed in [Chapter 5](#) of *Coverings*, long hair is unquestionably not that required covering, but actually demands the covering, and if not covered is to be shorn or shaved off.)

As you see in the list above:

- **Yahweh is the covering of Yahshua,**
- **Yahshua is the covering of the man, and**
- **The man is the covering of the woman.**

As long as the woman is looking to the man for an answer from Yahweh, she is under his covering; but, when she goes directly to Yahweh, she is now outside of his covering. Thus we see the following:

Yahweh

Yahshua

The man

The woman

Having moved out from under the covering of the man, Paul goes on to say that the woman “needs authority on her head, because of the angels” (11:10). While the woman was receiving from Yahweh through the man, she was covered by the man; but when she goes around the man and directly to Yahweh, He says that she needs authority on her head for the sake of the angels. This is Yahweh’s government. As addressed in *Coverings*, [Chapter 3](#), the Greek word here translated “authority” is “exousia,” which basically means here – “the right to speak.”

When a woman either speaks directly to Yahweh or on His behalf, she needs on her head the right to speak. At that point she is not speaking to her covering or on behalf of her covering, so Yahweh says that she needs a covering on her head as a testimony to the angels. And might it be noted here, this is not a social issue, but an angel issue, an issue of proper government that the ministering spirits before Yahweh in heaven recognize and respond to. These are the same angels through whom “the word (was) spoken” that “proved unalterable, and every transgression and disobedience received a just penalty” (Hebrews 2:2). These are the angels spoken of for whom Yahweh tells the woman to cover her head! Thus we find the following governmental order:

Yahweh

Yahshua

The man **Headcovering**

The woman

Whether you understand this or not, whether you agree with it or not, does not change its reality or the necessity of its practice or the certainty of its consequences on your life or, most notably, the awareness of the angels regarding your actions. Frankly, society today is a brief aberration from this long practiced truth (though men will still take their hats off to pray). As Paul wrote in verse 16 – “But if one is inclined to be contentious (about this matter of the woman covering her head), we have no other practice, nor have the churches of God.” In all the history of the church since Paul’s statement here, only since the Curse of 1920 have women unabashedly ceased to practice this clear command. This must be reversed!

Let us now consider this government regarding coverings from its unfolding larger picture. I am very grateful to the apostle, Linda, who asked a question about this that brought additional understanding, as you will see here, which is not found in the original *Coverings*.

First Yahweh created man, and for 2,000 years man was under the covering of his own flesh efforts. Then Yahweh began a new work – He created Abraham; and after Abraham brought forth Ishmael, the ongoing flesh work, Yahweh gave testimony that He would become the covering of this new work and fulfill it. We see then the first preceding governmental order:

Flesh efforts

Mankind

Abraham

Yahweh told Abraham that he and his offspring were to be circumcised in the flesh (Genesis 17:11), indicating that He would become Abraham’s covering, and not his flesh. He would bring forth the promised offspring of Abraham. (Read [The Covering Bride](#) regarding Abraham’s circumcision.) Abraham was thus set apart from mankind, and per the testimony of circumcision

Yahweh became his covering. Therefore, for the next 2,000 years Yahweh was the covering over the offspring of Abraham.

Flesh efforts

Mankind

Yahweh

Sons of Abraham

But Yahweh was not finished, for yet another 2,000 years later He once again called out another work, this time the body of Christ that came out of the sons of Abraham. Thus we see the preceding governmental order:

Yahweh

Sons of Abraham

Body of Christ

Since the body of Christ was coming out of the preceding work, then it too equally had to have a covering. What was that covering? It was Yahshua.

Yahweh

Sons of Abraham

Yahshua

Body of Christ

Once again for another period of 2,000 years there has been a work that has been under another covering, this one under the Son of God (though temporarily fulfilled by Satan, since the Son of God went back to heaven). But, it is now time to bring out another work – the former, Christianity, being the tithe; and the latter, the Remnant Bride, being the tithe of the tithe. (Keep in mind, these last two works have been the establishment of the kingdom of heaven on earth. This did not exist under the sons of Abraham.) So when the Remnant comes out, there obviously must be yet another covering.

With this basic governmental truth already established in this man's understanding in the days leading up to June, 1994, when the Spirit came upon me and Yahshua specifically told me that the body of Christ is put to sleep and a bride is taken out of its side, there was an obvious question that had to be asked. Governmentally, a bride coming out of the side of the body of Christ was precisely the same thing as what Paul presented in 1 Corinthians 11:1-16.

Furthermore, it is the precise pattern Yahweh has followed for 6,000 years per these three 2,000 year periods. Thus we now see:

Yahweh

Yahshua

The body of Christ **?**

The Bride

Once this man saw this, the obvious question was – What then was the covering that had to be applied to the Bride so that she would have the authority to pray and prophesy? Typically at that time, Yahweh answered my questions immediately; but on this one He waited three days and then told/showed me that it was the covering of holding all things in common, the very covering that Yahshua placed on the first Remnant through His clear teachings regarding this. This is addressed in [*One Thing You Still Lack*](#). Thus we see:

Yahweh

Yahshua

The body of Christ **All things in common**

The Bride

Thus, the government of (1) Yahweh over the sons of Abraham, (2) Yahshua over the body of Christ, and (3) holding all things in common over the Bride, is the identical government of (4) the woman covering her head! Once again, the critical application of this truth at all levels is inseparable, necessitating today more than ever that the woman cover her head and the Bride hold all things in common. They are one and the same governmental truth, and as Yahweh's "obedient people," we have no choice but to uphold them. It is quite revealing that today Christianity has rejected both of these latter two coverings, and in truth have thus reject Yahshua.

In summary, we see then the following wherein every 2,000 years Yahweh consistently takes out a remnant and puts a covering on it, each work being taken out of the preceding, and of necessity a new covering being applied:

And we add to this the highly revealing testimony that the woman is honored, truly honored, to present forth. For even as it is written in 1 Peter 3:1-2, by a woman covering her head, others “may be won without a word” by your example and testimony, “as they observe your chaste and respectful behavior.” Without a word the woman testifies of the works and ways of Yahweh.

The Curse of 1920 had its beginning in Christianity (*The Temptation of Eve ...*), and its ill affects have been advanced by Christianity. Likewise, a man’s hair needs to be short, and a woman’s hair needs to be long (1 Corinthians 11:14-15). Men need to be men, and women need to be women, and they need to quit abandoning their places and conforming to the rebellion of Satan. Wake up! Accept the image wherein you are made and quit fashioning an idol made by your own hands.

Similarly, this man finds it quite interesting that when Tabernacles, 2005, came and Yahweh provided me my Bride, I did not choose her. Instead, as are the ways of Yahweh, it was an arranged marriage. I chose my first wife, and she forsook me. I did not choose who would be the twelve apostles, but my Father chose them. Such is His ways; but even as Yahweh allowed men to divorce because of the hardness of their hearts, so He has allowed men to go out and choose their own wives out of their own passions (which by its very nature has continued to deteriorate into many divorces and numerous wives and even live-in relationships). Once you start compromising the ways of Yahweh, it is a certain slippery slope that you are on, and leads to one place – the bottom of the slope, the lowest point, sinking down into the mud! We have fallen a long way, and fail to either recognize it or to change it. We are blind and vain!

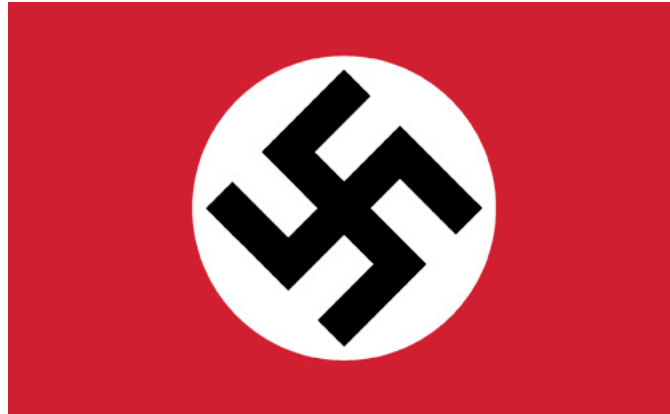
I am grateful to Yahweh that He chose my Bride, for He will keep her!

We know all too well what this flag meant to the world – horror and wholesale death and destruction. But what was it that Hitler was actually seeking to bring about? World War II, once again with the Germans, introduced a man who wanted to establish the Third Reich, or the “third kingdom.” What Hitler was seeking to accomplish at a nations level, was precisely where we are today!

The two World Wars with Germany were types of the 2,000 years of Christianity. Germany is prophetic of Christianity. It is the home of Martin Luther, whom Hitler quoted in his slaughtering of the Jews, those whom Luther absolutely hated. Let us read some of the remarks that German Luther wrote, and see how they were merely carried out by German Hitler. Here are excerpts from Luther’s instructions regarding the Jew:

First to set fire to their synagogues or schools and to bury and cover with dirt whatever will not burn, so that no man will ever again see a stone or cinder of them. This is to be done in honor of our Lord and of Christendom, so that God might see that we are Christians, and do not condone or knowingly tolerate such public lying, cursing, and blaspheming of his Son and of his Christians.

Second, I advise that their houses also be razed and destroyed.

Third, I advise that all their prayer books and Talmudic writings, in which such idolatry, lies, cursing and blasphemy are taught, be taken from them.

Fourth, I advise that their rabbis be forbidden to teach henceforth on pain of loss of life and limb.

Fifth, I advise that safe-conduct on the highways be abolished completely for the Jews.

Sixth, I advise that usury be prohibited to them, and that all cash and treasure of silver and gold be taken from them and put aside for safekeeping.

First, that their synagogues be burned down, and that all who are able toss in sulphur and pitch; it would be good if someone could also throw in some hellfire. That would demonstrate to God our serious resolve and be evidence to all the world that it was in

ignorance that we tolerated such houses, in which the Jews have reviled God, our dear Creator and Father, and his Son most shamefully up till now but that we have now given them their due reward.

What was it that Christianity had a responsibility to bring forth at the end of their 2,000 years? The third reich, the third kingdom! But did they do so? No more so than Hitler was able to establish the Third Reich at the nations level. And what is that third kingdom? It is the Millennial reign. And what did Hitler seek to bring forth that represented the Millennial reign at the nations level?

Hitler wanted purity. That is why he killed all the “undesirables” such as the physically and mentally afflicted, as well as the Jews. He wanted fitness and health and set forth many public health programs. He wanted purity in art and adopted a public program to destroy all abstract and vulgar art and to bring forth beauty and grace in sculptures and paintings and in music and architecture. His nation excelled in science and industry.

Hitler did all of this by his own personal strength; but in the end he failed to bring forth this purity and perfect order, in the same way that Christianity has failed. Thus, if Hitler failed at the nations level, and Christianity has equally failed at the kingdom level, what then is the hope for the third kingdom today – the Millennial reign? That hope is revealed in the German flag.

Because of Hitler, the swastika has become a sign of horror; but it has not always been such. In fact, the swastika was selected by the Nazis because of its immensely positive message. It is a symbol that has been used since ancient civilizations. Ancient Troy, India, China, American Indians, southern Europe, the Jews, many civilizations throughout the world have all used the swastika to mean good fortune, protection, strength, and life. By the Middle Ages, it was a well-known symbol and had many different names, depending on the country. During World War I, it was used on shoulder patches of members of the American 45th Division and the Finnish air force.

Before World War II it was used for product sales, by sports teams, civic organizations, on greeting cards, even in Jewish Synagogues. The word “swastika” stems from the Sanskrit, an ancient Indian language. There we find the word “Svastikah,” which means “wellbeing.” In ancient eastern cultures the word is related to things of good fortune. In many places the symbol is used to represent the sun, or as a symbol for the movement of the sun, and in other regards as a symbol for rebirth, because the sun turns continuously and gives rebirth to everything.

Following is a poster titled “The True Legend of the Swastika.” It will give you a good idea of the broad use of this symbol before World War II.

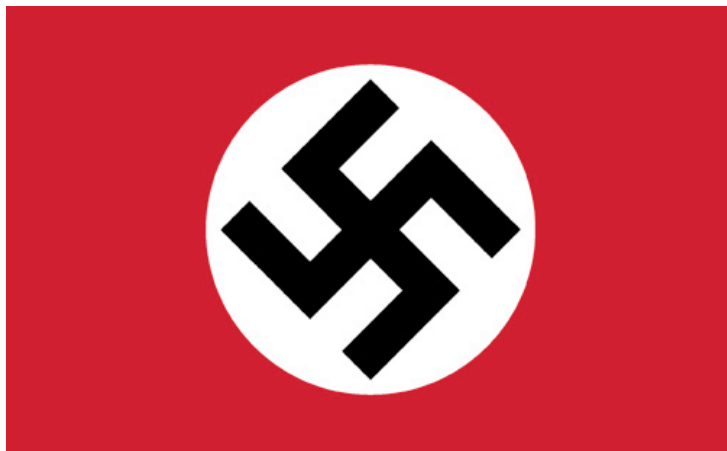
Once again we see – out of corruption comes life, out of failure comes deliverance and hope!
