The Moses And Elijah Works Fulfilled By Two Men—Part 3

The Father keeps adding to this matter, but this time through a Bride brother. Gratefully, Rian Burger, in Australia, saw some things that are quite amazing and wonderful, and sent them to me in a lengthy email. I myself had to read this several times to understand the fullness of what he was saying, and between the two of us it is available here for your benefit. But I can tell you, you cannot read this just casually. It is wonderful revealing and confirming truth, but it is not shallow reading. It even stretched me.

Following is the email Rian sent me, and on three occasions I add some comments and a link.

Gary,

I think what you wrote in the Report, "The Moses And Elijah Works Fulfilled By Two Men," is an important subject matter; and I very much agree with you that Yahweh builds His works upon men, rather than on a revelation or message. The revelation or message always comes through the man as well (given by Yahweh), which is why Peter in the first place revealed the truth about Yahshua being the Christ.

I would consider the passage in 1Peter 2:5-6 as further evidence of Yahweh building upon men:

Ye also, as lively stones, are built up a spiritual house, an holy priesthood, to offer up spiritual sacrifices, acceptable to God by Jesus Christ. Wherefore also it is contained in the scripture, Behold, I lay in Sion a chief corner stone, elect, precious: and he that believeth on him shall not be confounded.

So if Yahshua is the chief corner stone, and Peter the rock on which He builds His church, then the building of the work continues through "living stones" (men) in order to complete the work. But as you wrote, "Yahweh always chooses a solitary man to begin something." It would only make sense then that He would use a man, an Elijah, to start a new work, then continues that work and builds upon it until it becomes a corporate work - the "rib" taken out of the breach period of Christianity to form a "bride." The rib, of course, would represent the "solitary man," and is then used to build upon to form a corporate work, the Bride.

This also then further brings light as to why the work has to continue on the other side of the "breach," since it's like you said so many times before what

Yahweh had revealed to you in 1994: "**That which God did at the beginning of the church, He will do again at the end.**" If He in the beginning of the church used a man, Peter, to start a work that breached and died, then in the end He will once again use a man to start a work, but this time, most importantly, built upon him to completion.

And yes, the man in the end (Gary Naler) has received revelation from Yahweh, but the revelation only reveals the "Elijah" work that is being built upon, e.g. the bride actually being formed, rather than the revelation being used to build upon or from. This could well shed some light on the error that has caused Christianity to divide into over 33,000 denominations, as each denomination uses a part of a revelation or message in Scripture to build upon. Of course this then results in error and corruption, revealing the fact that they do NOT understand the ways of Yahweh, who builds upon men, and not upon revelation given to men.

Let me help you with this. Paul is an example of this failure. Paul died, the building stone was removed, and Christianity quickly became a multi-headed beast, even Babylonian confusion! Both Bride works are unique in that they are of short duration so that the building stone remains so as to insure a united work and message. Otherwise, they too would be corrupted. God builds upon a man, and when Paul died, every man was left to his own ways, thus providing divisive confusion. It then becomes just as that which was written in Judges 17:6 and 21:25: "In those days there was no king in Israel; every man did what was right in his own eyes." Thus today, there must be a culminating one-headed Elijah work. And in this latter work, unlike Peter, the head must remain unto to the ascension.

Christianity walks by revelation (sight/flesh), whereas those whom God chooses to build upon walks by faith (Spirit). This is the difference between one work that sees, believes, and acts (presumption), vs. hears, believes, and acts (faith). The work that builds upon revelation (sight/flesh), knows (or sees) only the "acts" of Yahweh (Ps. 103:7); but the work that builds upon living stones (men) that walk by faith, knows the "ways" of Yahweh. One leads to death, whereas the other leads to life. One has the promise, but dies; whereas the other receives the promise and lives.

In putting the above in a slightly different way, when Yahweh gives a revelation to a man, it would appear that two things can happen. (1) The man can make a presumption (sees, believes, and acts upon the revelation) and starts building upon the revelation **himself**, which will end in corruption and death. Or (2) the man walks by faith (hears, believes, and acts upon the revelation) and **Yahweh performs the work and starts building upon that man**; and the revelation given to that man will draw a multitude of "living stones" into obedience (like what is happening in Africa at this moment), upon which the work will be built to completion, leading to fullness of life. With the former, I'm wondering whether this is what Peter did. Perhaps he presumed that he could build upon the revelation given to him regarding Yahshua, and took it upon himself to choose a replacement for Judas, the 12th apostle, which caused the abomination of desolation? This would be similar to Moses, who made a presumptuous mistake and struck the rock instead of speaking to it, as instructed

by Yahweh. This would then make sense why the work caused the corruption of the kingdom and ended in death. It is also clear that Peter did not understand the ways of Yahweh, which is why he had to be put in his place for trying to prevent Yahshua from doing the will of the Father (Matt. 16:21-23).

There is something else I'm wondering about here as well. It almost seems to me that the seed of corruption started straight away after Peter received the revelation of who Yahshua was, in that Satan was speaking through him soon after that trying to persuade Him not to do the will of the Father, and then not long after that Peter denied Yahshua as well. Of course all of this had to happen because it was the first-bird work that had to die. But this cannot happen with the critical second-bird Isaac work, as it has to be an "**obedient people**" (Gen. 49:10) that Yahweh will use to build His bride work. Christianity is the Ismael result of Peter's presumption, as Ishmael was the presumptuous first-bird result from Abraham. The second Isaac work was by faith, as Abraham trusted Yahweh to perform it, and so the Bride work also has to be by faith so that it does not end in death, but life. The more I write about this, the more it's clear to me that faith is directly related to Yahweh building upon a solitary man, as you so clearly pointed out in the report. And, it also seems to strongly relate to the covenant pattern.

Regarding the above, it seems to subtly indicate that Yahweh did not build upon Peter because of the presumptuous mistake he made. But that would not be correct, as Yahshua obviously did not lie that He was going to build his church upon Peter. So the question then is: How did He, or how is He, going to build His church on Peter's failure? I think the answer to this question ties wonderfully in with what Yahweh has shown you regarding splitting a work in order to make it clean. Therefore, Yahweh had to split the Ishmael work He began with Peter with the breach 2,000 year period of Christianity, in order to make it clean on the other side with a man (Gary Naler) who would walk by faith and understand the ways of Yahweh. In support of this, I'll quote what you wrote in the report:

"The fact and reality is, the man Peter was the rock on which Yahshua built His church. But that work breached, and Christianity was then built on the man Saul/Paul. BOTH of these works had to begin with "a man," as has been the way of Yahweh since Adam. **And it is most evident that today the initiating Peter Moses work must be completed by, if I am seeing all things clearly, the Gary Elijah work.** Yahweh has to take a man today and do just what He did with the man Peter and the man Paul; and for whatever reason, He has revealed these things, and more, to this man. This is the Elijah work, fulfilling the promise given to the Moses work, so that the Mount of Transfiguration testimony can be fulfilled."

And:

And I would say as well, it is one man, the Elijah, who will cause a bride to be formed, even completed, and enter into immortality, being born from above, and return to rule and reign with Christ for a thousand years.

Unmistakably, God chooses to work from one man, just as we see with Peter, and even Paul. That is hopeful today. We look to the Father, and seek for Him to complete what He has begun.

AMEN!

So in summary, it seems that regardless of the outcome (death or life), Yahweh chooses to start a work by building upon a solitary man. But when a work is built upon a revelation given to that man, it is not Yahweh doing it (although He allows it). Instead, it is now a corrupt work like Christianity, formed by man's own attempts to bring about the kingdom of heaven by their own works and efforts (Matt 7:21-23). This only leads to death!

In proof of what Rian is saying here, what church is there today that does indeed claim to be built upon Peter? Is it not none other than the Catholic Church, which has at its roots all the way back to the beginning? And, do you see in it the fulfillment of Peter's works? Not in the least! It is a church in utter corruption. Upon adding this comment to Rian's original email to me, I sent this to him for a final proofing. And upon reading my comment here, he added the next two paragraphs.

I see the same thing with Paul. Christianity almost entirely bases their doctrines around his teachings which now has resulted in that "multi-headed beast" you mentioned earlier. Based on what you said about Peter and the Catholic Church, I'm wondering whether on a corrupt level, Protestant Christianity is doing what Paul did in Galatians, looking down upon and dissing the Catholic Church which is based (from their own efforts, works, and understanding) on the apostle Peter? In my experience from being a Christian, Protestant Christianity (especially Pentecostals) has always put themselves above the Catholics as being more correct and spiritual (even when they pretend to be united with them). If this is true, then the corruption of Christianity most likely started with Paul's presumptuous mistake in Galatians (you've pointed out on quite a few occasions), where he called the apostles "reputed" and said they meant nothing to him (Gal. 2:2-6)? One can then almost see the seed of corruption following down through each and every denomination, as each one claims to have the truth and looks down upon the other. Each one (pastor or minister that breaks away from a denomination to start another), so to speak becomes a Paul in their own right, causing further corruption in their congregation, further contributing to leavening the whole lump (Matt. 13:33, 1 Cor. 5:6 (context is different, but same principle), and Gal. 5:9).

I also can't but wonder if the whole "Mary" focus with the Catholic church is a corruption of the Bride work, as they put Mary (the female), above Yahshua (the male)? However, in one way it may be a corrupt testimony of the truth, because the way for Immanuel to be brought back to this earth is through the Mary Bride work, but she's clothed with the Sun (Rev 12:1), not above it.

So the pattern I see is this:

1. Yahweh starts a first-bird work by a solitary man to build upon. That man makes a presumptuous mistake and causes corruption in the corporate work that follows. This first work then dies.
2. Yahweh then establishes the breach, a waiting period where men run with their own imaginations and interpretations of the revelation given to the solitary man, and causes further corruption in the kingdom of heaven via their own works, efforts, and understanding.
3. Yahweh then starts a new work that is the second-bird work that is cleansed by virtue of the breach period ([split and flip to make it clean](#)), and builds upon a man once again, but this man walks by faith. This then results in a corporate work that consists of "living stones," an [obedient people](#). This work is then clean and acceptable to Yahweh, and can ascend alive!

The Passing over principle also seems to wonderfully tie in with all of this. Yahweh, passes over the first Moses work (started by Peter), He passes over the second breach Christianity work (started by Paul), and then accepts the third Elijah Bride work (started by Gary).

Abraham, the father of faith, intercessorally walked all of this out. Yahweh established a covenant pattern with him receiving revelation and the promise. Then he made a presumptuous mistake by trying to bring the fulfillment forth in his own way with Ishmael, which produced a long breach period. But then by faith he trusted Yahweh, and the Isaac, the second-bird work, was born by Yahweh bringing it to pass.

I recognize and appreciate the importance of this subject. It brings a clear distinction to whatever else has been done by man in relation to the kingdom of heaven, but failed. I think this important subject is all summed up in a short little phrase you once wrote in an email: "**By Yahweh, or not at all!**"

Upon completing this report, Rian suggested that you listen to the "Remnant Bride Radio" program titled "[True Faith and Its Trinity](#)." We are very grateful for what the Father is revealing here—more of the second Remnant Luke light.

And finally, Rian points out here that the Abraham "work" was in fact Ishmael, Isaac, and Jacob—the three parts of the Abraham church. Of course this is first Remnant, Christianity, and the fulfilling second Remnant. And it is entirely noteworthy that both of these Bride testimonies had twelve sons, clearly attesting to the former twelve and the latter twelve apostles. So briefly, what can we expect today? First, outside of Yahshua's testimony (John 1:51), second Remnant Jacob is the only man in the Bible who had the unique experience of seeing angels ascending and descending on a ladder that was set on the earth and its top reached up into heaven (Genesis 28:12). Frankly, this is the truth that we, the Bride, are receiving today, and that through one man. And,

when Jacob wrestled with an angel, he was given a new name, Israel (Genesis 32:24-28), which means: **“He Retains God**, or slightly more elaborate: **He Has Become A Receptacle In Which God Can Be Received And Retained”** (Abarim Publications). Amen! These are the things that we, the Jacob second Remnant, are fulfilling today.
